recommendation of the American Academy of Pediatrics telling parents not to spank their children. Their conclusion is that, to the child, spanking is "humiliating, scary or threatening." They even throw in some "data" suggesting a reduction in gray-matter volume in the prefrontal cortex in children subject to spanking. Needless to say, there is great division on the subject—and confusion. Is it right or wrong? Should parents spank their children or not? What does the Bible say?

There are two passages that come to mind, both in Proverbs:

- "He who spares his rod hates his son, but he who loves him disciplines him promptly" (Prov. 13:24).
- "Do not withhold correction from a child, for if you beat him with a rod, he will not die. You shall beat him with a rod, and deliver his soul from hell" (Prov. 23:13-14).

In both passages the real key is correction. Parents must correct bad behavior, or the child will set a course that ends in destruction. In both passages, God shows that parents should use the amount of force necessary for the correction. Some occasions may not call for a spanking, and some might. In these verses, God is placing His divine permission on the entire disciplinary process—up to and including the use of physical correction. In other words, he leaves the discretion to the parents. So here are some thoughts to ponder:

1. If spanking is administered correctly, it can be an important time of growth for parents and children. Spanking should be administered out of love, and should involve a time for explanation and reconnection. Remember that our goal is bring our children up in the Lord (Eph. 6:4). They need to understand why they are being disciplined and what behavior is expected as a part of the path to heaven.
