General Information and FACILITY RULES!

NO arrival prior to noon on Friday.

DOGS are allowed at the Competition. Owners MUST complete and turn into the office the permit along with a non-refundable deposit. Dogs are allowed in camping area and livestock areas, on leash ONLY. You MUST clean up after your dog(s). Dogs are not allowed in the buildings or lawn areas unless they are providing assistance to persons with disabilities.

BEDDING: One bedding provided. Only sawdust or shavings permitted. No straw. Extra bales of shavings available for purchase.

MANURE DISPOSAL: All manure, shavings, sawdust must be moved to designated manure pits, keeping paved roadways and areas around carts/pits clean of bedding and manure by picking up spillage. You must provide your own wheelbarrows. Dumpsters and trash containers will be available for all other garbage.

NO HORSES OR LIVESTOCK ALLOWED ON THE HILL SOUTH OF THE ARENA or in the Tacoma Members only Stecker arena between the entrance road and 176th.

If you have changes in stalling or camping, please notify the PNWDTA Secretary as soon as possible **in writing**. Unused stalls **MUST** be locked by Friday midnight. Additional fees or refunds must be arranged *prior to **SUNDAY morning!***

- 1) Participants **MUST** pay a \$20 per dog **NON-REFUNDABLE** deposit payable to the PNWDTA.
- 2) Dogs **MUST** be contained in a secure environment **OR** on a leash (attached to a human, or some device) at all times.
- 3) Owners/Handlers must **CLEAN UP** after their dogs.
- 4) Dogs are **ONLY** allowed in the camping areas.
- 5) Dogs are **NOT** allowed in the buildings/barns/arenas or lawn areas unless they are providing assistance to persons with disabilities.
- 6) ANY infraction WILL result in a \$50 Fine to the owner or team.**
