I have been made aware that certain adverse side effects may result which could include, but are not limited to; local bruising, minor bleeding, fainting, temporary pain or discomfort, and the possible aggravation of symptoms existing prior to acupuncture treatment. I understand that no guarantees concerning its use and effects are given to me and that I am free to stop acupuncture treatment at any time. Acupressure/Massage: I understand that I may be given acupressure or Oriental massage as part of my treatment to modify or prevent pain perception and/or to normalize physiological functions in an attempt to treat disease or dysfunction of the body. I have been made aware that certain adverse side effects may result which could include, but are not limited to; muscle soreness and the possible temporary aggravation of symptoms existing prior to treatment. I understand that I may stop this therapy if this is uncomfortable. Furthermore, I understand that this procedure is for therapeutic purposes only and that in a professional relationship sexual intimacy is never appropriate. Chinese Herbs: I understand that substances from the Oriental Materia Medica may be recommended to me to modify or prevent pain perception and/or to normalize physiological functions in an attempt to treat disease or dysfunction of the body. I understand that I am not required to take these substances but must follow the directions for administration and dosage if I do decide to take them. I have been made aware that certain adverse side effects may result from taking these substances. These could include, but are not limited to; changes in bowel movement, abdominal pain or discomfort, and the possible aggravation of symptoms existing prior to herbal treatment. Should I experience any problems that I associate with these substances, I should suspend taking them and call the acupuncture clinic as soon as possible.
- 2. *Procedure Explanation:* The practitioner has explained the treatment plan, including the number of sessions, duration, and expected benefits or potential risks.

- 3. Risks and Benefits: I understand that while acupuncture is generally safe, potential risks may include bruising, soreness, or slight bleeding at needle insertion sites. Rare complications like infection or nerve damage could occur but are extremely uncommon.
- 4. *Alternatives and Options:* I have been informed of alternative treatments or therapies available for my condition and have chosen acupuncture after considering these options.
- 5. *Confidentiality:* I acknowledge that my health information will be kept confidential and will only be shared with other healthcare providers if necessary for my treatment.
- 6. *Consent for Treatment*: I voluntarily consent to undergo acupuncture treatment and understand that I have the right to withdraw my consent at any time.
- 7. *Cost and Payment:* I understand the cost of the acupuncture sessions and the payment arrangements. I have been informed about insurance coverage, if applicable.
