Public Comments: Andrew Ahonen, Max and Rebecca McPherson, Lynn Haukkala, Jerry Hebert and Paul Hytinen attended the meeting to voice their opinions regarding the Mather Nursing Home building becoming a homeless shelter with problems regarding active drug users, needles, pipes, booze, loitering, the fighting and deaths, no sidewalks, lack of transportation and the need for public transit. Concerns about the safety of the children, schools (Christ The King, Aspen Ridge, and Westwood High) and the community within the Township including the wooded areas. Discussion regarding the problems Marquette is having at this time and possible impact on the hospital, fire fighters, and police departments. They are hoping the Board will take this into consideration. Residents moved here for the quiet and safety of allowing children to go outside freely and believe it is a horrible idea and should not be allowed and are also what negative impact it will have on their property value.

**Supervisor Comments  
For December 9, 2025**

1. Attended a webinar meeting put on by Fahey & Associates on Attainable Housing, Zoning, etc. on November 12, 2025.
2. Attended the Material Management Meeting at the Marquette County Landfill on 11/13/25.
3. Work on the sewer & water rate increases which would go into effect on January 1, 2026. Water will increase by \$1.00 per 1,000 gallons, \$0.50 operation and \$0.50 for future water project residential. Sewage will increase by \$4.00 per month, rate will go from \$36/mo. to \$40/mo.
4. Had a webinar meeting with EGLE and UP Engineering to discuss water grants, etc. from West Ishpeming on Friday, November 11<sup>th</sup>. A 20-year loan is at 2.5% and a 30-year loan at 2.75% at the present time.
5. The Marquette County Township Association Christmas Party was held at Ishpeming Township Hall on December 3, 2025.
6. I'll be at the Michigan Township Association meeting in Lansing on December 11 and 12.
7. Attended the Township/Road Commission Meeting on 12/4/25. Discussion on work completed this year and projects for next year. Talked about succession planning for replacement of employees retiring.
