- 3. Checked with Township attorney, register of deeds, and Assessor on the definition of "utility easement", haven't found the exact wording, but the Township Assessor said that the access needs to be clear for utility companies to get into maintain their utilities.
- 4. Contacted the Department of Agriculture on the birds on Marble street and they sent their inspector there. Erin said Lusardi's residence does not fall under the Right to Farm Act.
- 5. Attended the Supervisor/Managers meeting at the City of Marquette. Discussions were held on new business in Marquette (recycling, hospital, etc.).
- 6. Mike Kohler, Ishpeming Township's new Police Chief, started work on August 5, 2019. He was busy on the first day.
- 7. Attended the Planning Commission meeting on August 6, 2019. Discussion on the proposed marijuana store in Ishpeming Township.

Is it worth reviewing how many Residences don't pay, how many of these go to the transfer station, if they don't go there -where does there garbage go. Turn on/off fee seems excessive for seasonal camps/snowbirds. Does our auditors look into this? Supervisor will look into rate structure
