#### December 12, 2023 Board Meeting

- 1. Attended meeting at Marquette Township on 11/16/23 with Senator Ed McBroom, Rep. Greg Markkanen and David Prestin. Discussion on the new energy bill (H.B No. 5120) which was recently passed. The new bill for larger solar wind energy projects will fall under State Zoning Rules.
- 2. Attended meeting at Marquette Township on November 20, 2023, with Rep. Jenn Hill and Ed McBroom to discuss House Bill 5120 which Jenn voted in favor of. Most of the people at the meeting objected to giving up the zoning from the local to the state monitoring for the big projects.
- 3. Sat on panel for Lake Superior Leadership Academy Government Day at Marquette Township on December 7, 2023.
- 4. Attended the Township/Road Commission Relations Committee Meeting on December 7, 2023. Discussion on road work for 2024 throughout the various Townships. Approximately 26 miles of chip seal is scheduled for 2024.
- 5. Talk to Jim Grundstrom from Fox Marquette on the delivery of the garbage truck. Due to the strike he expects it to be delivered early January 2024.
