7. Public Comment: Dave Miron, 925 N. Westwood Drive, Ishpeming, complained about 2 homes that have numerous dogs in neighborhood making noise, barking excessively, fighting, smells on humid days, owner is disposing of dog poop by burning it, and digging. He is worried about someone getting hurt if they were to get loose. He discussed the problem with under age kids on dirt bikes with no mufflers driving in neighborhood, and asked if there was a fence permit for 1060 School Street. Supervisor Nankervis believes the Officer has been working on it and will follow up with Officer Kohler when he is back from vacation.

William Jalonen, 2013 Washington Avenue, Ishpeming, complained about fences (good side facing wrong way), trees growing into right away making it difficult for access and delivery trucks. Blight brush not being taken care causing rodents taking over in the Deer Lake area. He believes it is de-valuing property. He asked the Township Board to take action on blight and fence ordinance. <a href="Supervisor Nankervis">Supervisor Nankervis</a> stated the Road Commission owns the right away and will have them take a look at it. <a href="Treasurer Thornton">Treasurer Thornton</a> stated that this is something that needs to be addressed. The Board did not vote on anything but will follow up on the concerns.

Rick Watson, 1015 N. Westwood Drive, Ishpeming, complained about the barking, burning of dog crap, can't open windows. He asked about if the ordinance says how many dogs you can have, if the dogs have shots. Supervisor Nankervis said he will have the Officer check into it. He believes there is something in the ordinance regarding noise and talked about a neighborhood watch that the neighborhood had in the past. Treasurer Thornton stated we will do what we can.

## July 12, 2022 Board Meeting

Met with Jake Skewis (property owner on south side Ellsworth Street in Harris Hill Subdivision area), Moyle Construction, Drain Commissioner Mike Ferrell, and MCRC Engineer Kurt Taavola to discuss the storm sewers on the property. Owner wants to move them to the back of the lot in the area of the sanitary sewers which I opposed.
- 2. Attended the WMCSA meeting on June 20, 2022, and the Transfer Station employees attended requesting raises and a new truck, etc. I decided after the meeting I was going to resign as the Manager effective July 11, 2022. The WMCSA Board met and hired Kristin Thornton as the new manager. I was there, I believe for 30 years, that's long enough.
- 3. I met members from the Recycling Partnership at the Marquette County Landfill to be interviewed about recycling in Ishpeming Township. They have recommended Ishpeming Township for a Recycling Award. Maybe Ishpeming Township will be recognized for recycling.
- 4. Attended the Michigan Township Association meeting in Port Huron, MI on June 23 and 24, 2022.
- 5. Attended the Public Hearing on Ishpeming Township Project Plan for the Drinking Water State Revolving Fund EGLE. It was held at 6:00 p.m. on Tuesday, June 28, 2022 at Ishpeming Township.
