FOR May 14, 2019 BOARD MEETING

1. Attended the FEMA meeting at the Marquette County courthouse on May 1, 2019. They had maps on the flood zone for the Carp River and Dead River drainage area.
2. Attended the Managers/Supervisor meeting at the City of Negaunee on May 2, 2019. Discussion on the proposed launch site at K.I. Sawyer, upcoming census meeting at Marquette Township, Hydro-Power study using the underground mines.
3. Attended the Census 2020 meeting at Marquette Township Hall on Monday, May 6, 2019. Ishpeming Township needs to get the word out that everyone in the Township, needs to get counted. Get the information on our website, meetings, newsletter, etc.
4. Attended the Marquette County Township Assoc. spring banquet at Michigamme Township Hall on May 8, 2019.
5. Attended the Planning Commission meeting on May 7, 2019. Thyra Karlstrom, Marquette County Planner, gave a talk about the Marquette County 2040 Master Plan.
6. Attended a GIS seminar at the Equalization office in Marquette on May 9, 2019. Equalization is looking at purchasing the package. You could add sketches and floor plans to the parcels.
7. Met with Mike Kohler at Ishpeming Township office to look at his office, police equipment, car etc. He will be making a list of uniform requirements and other items he needs.
8. Started on the new dugouts for the Fireman's ballfield. The concrete slabs are being worked on and the mason's will be here mid-week of May 13 to place the concrete block.
9. Working on getting prices on bit asphalt parking lot replacement at Ishpeming Township. Also getting pricing on replacing existing bit asphalt with a 6" concrete slab on the north side of the office and fire hall out to the highway.
10. We have one application for the summer student position, trying to get more applications, in contact with school and agreed to hire Nathan Beckman starting June 3rd until August 9<sup>th</sup>.
