For October 8, 2024, Board Meeting

- 1. Attended a webinar on the County Data Booklet with Rachel Raak to discuss the growth in Marquette County on September 26, 2024.
- 2. Attended the Marquette County Township Association meeting at Negaunee Township on Wednesday, September 25, 2024. Enbridge gave a presentation on Line 5 Pipeline. Hoping to start on the tunnel beneath the Straits of Mackinac in 2026.
- 3. Worked on recommendations for new sewer rates due to increase for Ishpeming Township at IAJWWTP of \$6561.30/month. Recommendation is to increase residential sewer to \$36/month and commercial to \$8.00/1000 gallons.
- 4. Reviewed the hall rental fee schedule and it appears that we should be increasing rates to cover some of the expenses.
- 5. Attended the AWWA Fall Water Conference at the Island Casino on October 1-2, 2024, with Craig. Lead and copper updates have to be in to the state by October 16, 2024.
- 6. Met with Ben from Peninsula Solar and we filled out the forms for the solar panels. We will be getting more information to fill out.
- 7. Worked on addresses for individuals living or have cabins on a road along Clark Creek in Ishpeming Township. Working with Central Dispatch we will be calling the road North Clark Creek Trail and give them addresses on that road instead of County Road GGT.
- 8. Attended a get together at Jerzi's on 10/5/24 to meet the Michigan speaker of the House Joe Tate. Told we need grant money to replace the water system in West Ishpeming.
- 9. Sent paperwork to the Assessor on Dollar General wanting to reduce their Assess and State Equalized Value of their property.
- 10. DPW will be finishing on the lead and copper checks. They will have their 20% checked and report in by October 16, 2024.
