**2025 Breeding Fee:**

The 2025 breeding fee is \$1000, which includes a nonrefundable booking fee of \$200 that is due upon initiation of this contract. The Mare Owner agrees to pay the remaining balance of the breeding fee and chute/shipping costs prior to shipment of semen. There is a 4% credit card fee where applicable. The 2025 breeding season will begin February 3<sup>rd</sup>, and conclude June 6<sup>th</sup>. Later dates in June/July can be accommodated pending The Stallion Owner's show schedule for those that need late shipments.

**Shipping Terms and Conditions:**

Chute Fee (Including disposable container): \$385  
UPS overnight shipping fee (Monday-Thursday): \$185  
UPS overnight Saturday delivery: \$220  
Counter to Counter Shipment (From Orlando Only, includes currier fee): \$400

**Breeding Conditions:**

Collection days are Monday/Wednesday/Friday. The Stallion Owner must be notified by 4pm EST on the day prior to a standard collection day. It is The Mare Owner's responsibility to make sure contact is made via call or text to The Stallion Owner (Caylee Lane) at 386-843-2511 to confirm the need of a shipment. Any remaining contract balances and applicable charges for chute/shipping fees must also be paid by 4pm EST the day before collection.

It is The Mare Owner's responsibility to ensure the mare is in sound breeding condition and free from infection or disease. If the mare becomes unfit for breeding during the course of this contract, an alternative mare can be substituted as long as previously agreed upon by The Mare Owner and The Stallion Owner. Sale of an unused breeding is subject to The Stallion Owner's approval. A \$200 rebooking fee will apply to transfer the breeding contract.

**Foal Terms:**

The Mare Owner is responsible for registering the foal with the appropriate breed registry. The Stallion Owner will provide necessary documentation and assistance for registration.

The Stallion Owner provides a live foal guarantee. A "live foal" is defined as a foal that stands and nurses within 24 hours of birth. If the foal does not meet this criteria, proper notification must be made to The Stallion Owner. The Stallion Owner will offer a rebreed at no cost to The Mare Owner; chute fee and shipping charges will apply. If a rebreeding is necessary, it will be provided during the subsequent breeding season. The rebreeding will be subject to availability and the same terms as this contract.

**Termination:**

The Stallion Owner may terminate this contract if the Stallion becomes unfit for breeding or if the Mare Owner fails to meet the payment obligations. The Mare Owner may terminate this contract with notice to The Stallion Owner via call or text (Caylee Lane 386-843-2511). In such cases, the booking fee is non-refundable.
