



## GENERAL TERMS & CONDITIONS

PETROCHEM USA, INC.

**AMENDMENTS:** Any modification of this document by the customer, and all additional or different terms included in the customer's purchase order or any other document responding to this contract, are hereby rejected. BY REQUESTING THE GOODS AND SERVICES SET FORTH HEREIN, BUYER AGREES TO ALL THE TERMS AND CONDITIONS CONTAINED ON ALL THREE (4) PAGES OF THIS DOCUMENT.

**PAYMENT TERMS:** Prices quoted are in U.S. Dollars and are based on either payment in advance or letter of credit. In the event that Customer disputes any part of an invoice, Customer shall notify PETROCHEM USA, INC. thereof specifying the reason for such a dispute and the undisputed part of the invoice shall be paid without any delay. Once the disputed items are cleared, such must be paid immediately. In the event it is necessary to effect collection of outstanding accounts, Customer agrees to pay all fees directly or indirectly incurred for such collection. Service charge of 1 1/2% per month will be charged on overdue account.

**TAXES:** Any tax assessed in the country of operations on the charges made for the sale of products shall be for the customer's account.

**INDEPENDENT CONTRACTOR:** PETROCHEM USA, INC. is and shall be an independent contractor with respect to the performance of this contract, and neither PETROCHEM USA, INC. nor anyone employed by PETROCHEM USA, INC. shall be the agent, representative, employee or servant of Customer in the performance of this contract or any part hereof.

**FORCE MAJEURE:** Any delays or failure by PETROCHEM USA, INC. in the performance of this contract shall be excused if and to the extent caused by war, fire, flood, strike, labor trouble, accident, riot, machinery breakdown, acts of God, or any contingencies beyond the reasonable control of PETROCHEM USA, INC.

**DISPOSAL:** Disposal of the chemicals used in the performance of this contract is the responsibility of Customer. Customer agrees the chemicals will be disposed of in accordance with all applicable Federal, Provincial and local laws and regulations.

**PRODUCT SALES AND RENTALS – WARRANTY:** PETROCHEM USA, INC. MAKES NO WARRANTY OF MERCHANTABILITY, OR THAT SAID PRODUCTS SHALL BE FIT FOR ANY PARTICULAR PURPOSE, NOR IS THERE ANY OTHER WARRANTY EXPRESSED OR IMPLIED EXCEPT AS EXPRESSLY STATED HEREIN. PETROCHEM USA, INC. liability and Customer's exclusive remedy for any cause of action rising out of a product sale pursuant hereto is described below.

The customer is responsible to obtain product samples from Petrochem USA, Inc. prior to purchase. The samples are to be laboratory tested using specific well data, local cement and location water in order to verify that the product/s they are ordering will meet their application/s. The laboratory results are to be emailed to Petrochem USA, Inc. which will be kept on file. In the unlikely event the customer reports that the delivered product/s do not provide similar laboratory results to the original laboratory test results, the customer is to provide the unsatisfactory laboratory results to Petrochem USA, Inc. for comparison and verification.



If the reported test results are considerably different to the original laboratory results, Petrochem will re-test the product/s using samples that Petrochem retained from the referenced order. If the re-test results are within acceptable limits of the original acceptable results the customer will be charged for the re-testing cost. However, if the results are significantly different, the customer will need to return the product/s (at the customers cost) to Petrochem USA, Inc. and at the option of Petrochem USA, Inc. either a replacement or refund will be made.

If however the client disregards the above testing procedure, Petrochem USA, Inc. will not be responsible for any non-performance of the product/s ordered and/or shipped. Petrochem USA, Inc. also does not have a return policy for any product/s, nor do we offer any exchange, credit or replacement of products and therefore all orders are final when placed.

The parties agree that Customer has complete custody and control of the well, the conditions created in the well, the drilling equipment, well premises and access routes from highways to well locations. Customer will have the well in readiness for the service and, following service, will return the well to production. Customer shall be fully responsible for and defend, indemnify and save harmless PETROCHEM USA, INC. its officers, agents and employees against:

- (I) Liability to damage to property of customer (and well owner if different from Customer), this provision applying but not limited to subsurface damage and surface damage arising from subsurface damage including any liability based in whole or in part of the negligence of PETROCHEM USA, INC.
- (II) Liability for reservoir loss or damage, or any property damage (including but not limited to damages caused by pollution or Contamination), or personal injuries resulting directly or indirectly from subsurface pressure, well blowout or cratering, or losing control of the well including any liability based in whole or in part on the negligence of PETROCHEM USA, INC.
- (III) Liability for any damages whatever resulting directly or indirectly from a subsurface trespass, pollution or contamination arising out of any servicing operation performed by PETROCHEM USA, INC. for Customer including any liability based in whole or in part on the negligence of PETROCHEM USA, INC.
- (IV) Liability for injury to persons (including death) or damage to property, other than employees and property of PETROCHEM USA, INC. growing out of or in any way, connected with the use of materials in the well which are radioactive, poison, toxic or otherwise hazardous including any liability based in whole or in part on the negligence of PETROCHEM USA, INC.
- (V) Liability for injury to persons (including death) or damage to property growing out of or in any way connected to the use of various equipment provided by PETROCHEM USA, INC. for the sole convenience of and use of the Buyer including any Liability based in whole or in part on the negligence of PETROCHEM USA, INC.
- (VI) Liability for damage to property of Customer (and well owner if different from customer) resulting, directly or indirectly, from tools or instruments of PETROCHEM USA, INC. being lost in the well, including any liability based in whole or in part on the negligence of PETROCHEM USA, INC.
