It's important to note that your proof of eligibility must be current and verified. That means that it cannot be expired, cancelled, or voided.



Your offer of employment will be subject to verification of your eligibility, so it's important that you have the necessary documentation on hand when applying for jobs. If you are unable to provide evidence of your eligibility at least 6 weeks before the start date specified in the job offer, the employer may be forced to rescind the offer of employment. To avoid any issues, make sure that you have all of the necessary documents ready to go and that they are up-to-date and valid. If you're unsure about which documents you need, it's a good idea to speak with an immigration expert who can provide guidance and advice. Applying for work permit outside Canada: According to the guidelines, a foreign person may apply for an open work permit outside of Canada, at a port of entry, or after arriving in Canada. If your application is approved while you are outside Canada, you will get instructions on obtaining your work permit at the Canadian border (POE). If you submitted your application online, the letter would be available in your account. Or, if applied by mail, you would get a letter at your address. When to apply for a work permit? The requirements in Canada are as follows: while some exemptions are applied, foreign individuals generally need to hold a valid work permit to work in Canada. If you want to submit a work permit application, you must have an offer of employment by a Canadian company supported by a Labour Market Impact Assessment (LMIA). Please note that foreign workers may not need to have an LMIA or a job offer to apply for a work permit in some cases. This is true for those who have recently graduated from a Canadian Designated Learning Institute (DLI) or for the spouse of someone who is already in Canada on a work or study permit.
