RENTAL CONTRACT TERMS

- The undersigned agrees to rent the instrument for a minimum of two (2) months. At the end of this initial two-month period, a ten percent (10%) discount will be given if a twelve (12) month rental is paid in full.
- Payments are due on the date of contract each month unless this occurs on Saturday, Sunday or a Monday holiday then payment will be on the Friday preceding. Payment will be considered past due if not received within 30 days of contract date. Past due accounts are assessed a \$5 late fee per month, compounded monthly, and is not negotiable. Ex: If your bill was due Jan. 1, and no payment is made until Apr. 1, the late fee would be \$30 (\$15 Jan., \$10 Feb., \$5 Apr.). If an account is in arrears, the late payment is not counted toward rental credit.
- I, the undersigned, give Robert H. Gordon III, Violinmaker, my credit card information as security for the instrument I am renting. If my account becomes delinquent by 90 days (three months), all rental equity is forfeited, and the full value of the instrument becomes due and collectible. I give Robert H. Gordon III, Violinmaker permission to charge the full price of the instrument to my credit card.
- Maintenance and Repair Option covers fire, theft and serious damage. Broken strings, worn bow hair or negligent loss is not covered under the Maintenance and Repair Option. Renter must show proof of insurance if the Maintenance and Repair Option is not used. All repairs and adjustments must be done by Robert H. Gordon III, Violinmaker, except for string replacement or the Maintenance and Repair Option is null and void. Maintenance and Repair Option payment is not counted toward rental credit.
- I understand that this is not a rent to own program.
- Forty percent (40%) of the total rental fees accumulated can be applied to the purchase of an instrument of the same kind. For instruments \$4,999 and under, a maximum of half the value of the instrument can be paid by the accumulated rental credit. For instruments \$5,000 or more, accumulated rental payment credit is applied up to a maximum of forty percent (40%) of the value of the instrument. Instrument values are determined by Robert H. Gordon III, Violinmaker.
- Rental credit must be used within ninety (90) days of the return date or be forfeited.
- Instruments must be returned to Robert H. Gordon III, Violinmaker, 142 Franklin Street, PO Box 24, Belsano, PA 15922.
- I agree that failure to comply with the terms of this contract or failure to return the instrument on demand, gives Robert H. Gordon III, Violinmaker the right to terminate this agreement without notice and collect the instrument immediately.
