Application Requirements

Complete applications will be processed in the order they are received. The application is considered pending until all requirements are met. Applications are accepted until an applicant is approved and a **Holding Deposit** is received.

Approved Applications:

Please note that if we do not receive the holding deposit after 24 hours, the apartment will go to the next approved applicant.

- 1. Upon approval of your application, you will have 24 hours to bring in a Holding Deposit (money order or cashier's check).
- 2. Holding Deposit is \$500. Funds will be applied to move-in charges.
- 3. Sign a Holding Deposit Agreement. The Holding Deposit Agreement states that you will take possession within 14 days from the date you signed the Agreement.
