In order to file a Small Claims Complaint the amount needs to be \$7000 or less and the Defendant must be served within Flathead County, Montana, per MCA 25-35-502

- 1. You have received a packet that contains the following documents:
 - a. Small Claims Complaint (2 pages)
 - b. Praecipe for Service
 - c. List of Process Servers
- 2. Please follow the directions below for completing the above-referenced forms in order to properly file your Complaint.

3. **COMPLAINT** (original and copy for you and copy for each defendant)

- a. You are the Plaintiff, print or type your name or the name of your business
- b. The person you are suing is the Defendant, print or type the name of the person
- c. Fill out the amount you are suing for and the reason you are owed this debt
- d. Complete Plaintiff area with phone number, email, print name and provide mailing address. **Do not sign the document until you are in front of the court clerk or a notary.**
- e. Complete Defendant area in the bottom left hand corner with addresses and phone number

4. <u>PRAECIPE FOR SERVICE</u> (original) This will be given to the Process Server in order to help them locate and serve the Defendant(s)

- a. Print your name under Plaintiff (should be the same as is on the Complaint)
- b. Print the name of the Defendant (should be the same as is on the Complaint)
- c. Indicate what Process Server you would like to serve your Complaint (list is attached)
- d. Select Summons and Complaint
- e. Print the defendant's home address, work address or any other place they can be located and served
- f. Sign and date this document
- g. Complete the Plaintiff area with address and phone number information
- 5. A \$30 filing fee must accompany the Complaint. Payment must be Cash, check or money order made out to Justice Court. Credit cards are <u>not</u> accepted.
