The REC&U Program is designed to provide before and after-school care for students attending Mooresville Consolidated School Corporation's Elementary Schools and the Little Pioneer Preschool Program. Mooresville Parks & Recreation District aims to help students build upon their strengths through recreation, enrichment, and community involvement. The program is divided into three core areas: Active Kids are Healthy Kids, Homework & Enrichment Time, and Emotional Learning.



## REC&U Program at a Glance

- **Registration:** Registration for the 2024-2025 school year begins June 24 @ 8 am online at www.mooresvilleparks.com.
- **Drop off:** Students may be dropped off at their attending school no earlier than 6:30 a.m.
- **Pickup:** Students must be picked up at their attending school no later than 6:00p.
- 2-hour delays: The RECU Before School Care program will open at 6:30 am on 2-hour delays.
- School Closures, eLearning & Holidays: The RECU program will NOT be offered when school is closed for holidays, weather-related closures, or eLearning Days.
- **Attendance:** A minimum 10-day notice is required for schedule changes.
- Drop-In Service: RECU is NOT a drop-in program.
- **Payments:** Weekly payments are due the Friday before the week of care begins.
- **Payment Adjustments:** Refunds and credits are not issued for unforeseen closures (weather), illness, or sudden changes in the attendance schedule.
- Extended Breaks: The RECU Before/After School program does not operate during breaks. The Park offers BREAK CAMP during extended school breaks, which requires a separate registration.
- Financial Assistance: The REC&U Fee Structure utilizes a sliding scale based on qualification for the USDA Free & Reduced Lunch Program. This means the program's cost may be reduced for families who qualify for free or reduced-price lunches. Letter of qualification (Reduced/Free Lunch) must be presented to the Park Office each school year.
