Moving into a new neighborhood with an HOA can be a learning process. A great place to start is right here reviewing the contents of this packet that contains some important dos and don'ts, i.e., making changes to your home such as repainting, relandscaping, or putting in a pool. Changes such as these must be requested in writing and approved by our Architectural Committee prior to being implemented. Architectural forms and a wealth of other information can be found on our website, www.mymontevista.com, so be sure to check out how to register on the Homeowner Portal information sheet. Our management company, Arizona Community Management Services (AZCMS), can be contacted as well at 480- 355-1190 to address any issues or concerns and to help ensure your home is in compliance with our CC&Rs.

Our Board of Directors currently holds meetings on the third Thursday of each month at 6:00 p.m. via Zoom to keep residents up to date on what is going on throughout Montevista. There is an open homeowners' forum for questions and discussion at the end. Meetings usually last about an hour. Attendees are encouraged to sign up for one of our HOA committees as a means to meet other volunteers and become involved in your new community. Once signed up on our website, residents will receive text and email blasts as a reminder of upcoming meetings and other important events. Notable Notes

Please do not make changes to your landscaping, paint, gravel or turf; add gutters, a pool, spa, pergola, built-in barbecue or the like without first filling out an architectural application form found under the Architectural Committee link on our website, www.mymontevista.com. Any changes must first be submitted to and approved by our Architectural Committee. Montevista's approved plant and tree list can be found on that link as well.

It is a good idea to familiarize yourself with our CC&Rs. New residents are required to sign off with their title company that all documents, including CC&Rs, were received. Our CC&Rs can also be found on our website, www.mymontevista.com under 'Documents'. If you encounter a problem finding this information or have any questions, please contact our management company, AZCMS at (480) 355-1190.

Residents who need to report an emergency after-hours or on weekends, please utilize our AZCMS After-Hours Emergency Line at (480) 355-1190 and press '7' to be directed to the emergency line mailbox.

There are specific rules addressing parking that can be found in our CC&Rs under Section 3.14 and 3.12c, 'Parking Enforcement'. Montevista's streets are **private**. They are maintained by our HOA and not the City. Some areas throughout the community are narrowed to discourage speeding, and there are many cul-de-sacs throughout as well. It is very important that parking rules be followed so that emergency vehicles have quick and easy access to our homes. Parking on the street also restricts access for landscape trailers, delivery trucks, etc. Whenever possible, please do not park on the streets.

Ready to repaint? Multiple exterior paint schemes can be found on our website at www.mymontevista.com. In addition, they can be found on the Sherwin-Williams website (www.sherwin-williams.com). Montevista has 16 different paint schemes to choose from containing 106 color combinations. Once logged into our homeowners portal, simply scroll down to Resident > Documents > Montevista Paint Schemes. Homeowners must submit an architectural request form, even if repainting using the same colors, and must receive approval from the Architectural Committee prior to proceeding. If you have any questions, please contact AZCMS.

Be prepared to overseed your front lawn to winter rye starting in October. Homeowners also have the option of using artificial turf. Samples of approved turf and vendors can be found on our website via the Architectural Committee link. Plans must be submitted to the Architectural Committee for approval prior to installation. Make sure you have the approved gravel in your yard before making any changes to it as well.



News You Can Use

Signing up for e-statements is easy and saves our HOA money by not having to pay for printing and postage. One can sign up for e-statements by going to https://azcms.opt-e-mail.com/signup to register. You will then have the ability to control how your HOA statements are delivered to you. Once signed up, your HOA quarterly dues payments can be made online by visiting https://azcms.com/make-payment/ and selecting PAY BY DEBIT (FCB BANK). Save a tree, go paperless!
