

CENTER TUITION AND CONTRACTUAL AGREEMENT Little's Athletics & Education 2021 (COVID-19)

I understand that, by signing this contract, I agree to abide by the following policies and procedures as well as those listed in the Little's Athletics & Education Parent Handbook. I also understand that failure to adhere to these policies/procedures could result in the dismissal of my child(ren) from the Little's Athletics & Education program.

I agree to pay my tuition by the start of the program, [REDACTED]. Tuition includes daily care for any and all dates scheduled for a service, class, or program. No credits or refunds will be given for any missed days, late cancellations (within 8 hours of start time), closures, or emergency closures including but not limited to illnesses, weather related closings, pandemics, etc... If my tuition has not been paid by the first day of the month of service, I understand that my child will not be allowed to attend the Little's Athletics & Education program. I further understand that my child will not be readmitted to the program until space is available and all fees, including late fees, have been paid. In addition, I shall be responsible for any attorney or collection fees required to collect unpaid tuition and/or any other outstanding charges which may include late tuition fees or late pick-up fees. A detailed calendar of closing procedures is available in the Parent Handbook. I understand that there may be changes made to the calendar if necessary.

I understand that any days missed during an emergency closure due to COVID-19 will not be credited or refunded. In the event of an emergency closure due to COVID-19, I understand that I must provide a written two week notice to de-enroll. No exceptions will be given.

I have read and understand all additional policies regarding COVID-19.

I have read and am aware of all of the risks associated with sending my child to child care amidst the COVID-19 pandemic and will not hold Little's Athletics & Education liable in the event that my child or family contracts COVID-19. I agree to maintain a labeled, daily supply of personal care items (i.e. complete change of clothes, water bottle, snacks and lunch, materials collected from home to avoid sharing of materials while at camp, etc).

I agree that I will not send my child to Little's Athletics & Education if they are showing any signs of illness.

I agree that I will prescreen my child with temperature checks and symptom checks to assure there are no signs of illness.

I understand that photographs or videos of my child may be taken and used for promotional material.

I have read and understand the Discipline Policy located in the Parent Handbook.

I agree to treat the Little's Athletics & Education team members, as well as all children in the center, with respect and consideration.

I agree to follow all Little's Athletics & Education rules and policies, including policies regarding COVID-19 procedures, whether written or posted on site.

I, the parent/guardian of the individual, a minor (the "child"), do hereby permit the child to participate in Little's Athletics & Education program and certify that the child's physical condition is sufficient for full participation. I understand that the child's participation in Little's Athletics & Education's program involves an element of risk and a possible danger of accidents. I also understand that the child's participation may include activities involving athletes of different ages participating together and also those of varying gender. If an emergency arises at any point during the session, I assume all risk and agree to hold harmless, and release and discharge Little's Athletics & Education, L.L.C. and all employees from any and all liability resulting from the child's participation in any aspect of Little's Athletics & Education program. I also understand that in the case of injury or sickness, every attempt will be made to contact me, but in case I cannot be reached, I give my consent for my child to be treated by emergency and medical care professionals, as they deem necessary.
