### SYNOPSIS OF BY-LAWS

#### ARTICLE IV: MEETINGS

##### Sec. 1 Annual Meetings:

- Meetings shall be held on the third Sunday of October for the purpose of electing by vote the succeeding Board.
- A meeting shall be held on the third Sunday of May to present officers, committee reports, and financial implications of the upcoming year.
- All meetings will also be open for the transaction of any business deemed necessary and within the powers of the Association.

#### ARTICLE V: QUORUM

Sec. 1: A quorum shall consist of four (4) members of the Executive Board. It is in the best interest of each and every Executive Board member to attend the meetings of the Association in order to have a vote on all matters.

#### ARTICLE IX: EXECUTIVE BOARD

##### Sec. 2 The powers of the Executive Board shall be:

- (a) The business and property of the Association shall be conducted and managed by the Executive Board.

### SCSCA OFFERS OUR MEMBERS USE OF....

**Large Beach Area**...featuring a paved & covered pavilion with picnic tables & fans. Access to a volleyball net, basketball hoop, sandy beach & swings for all ages. Two swim platforms and ladders, and an Osprey nest platform. Main meeting area of the community.

**Three Decked Piers**...enjoy yourself with fishing, crabbing, swimming, sunbathing, or sit back & relax while watching our amazing sunsets.

**Two Ramp Accesses**... with paved ramps for boat launching.

## LOCATIONS OF THE ASSOCIATION

**PARCEL ONE:** Large beach area where Potomac Avenue and St. Clements Avenue meet. Main Community Beach and Pavilion.

**PARCEL TWO:** Four areas commonly known as “Fire Lanes” or Ramp Accesses to the Bay:

1. End of St. Mary's Street, includes a wide paved launching ramp & pier.
2. St. Clements Avenue, water access. Just north of Lee St. Provides the opportunity to sit at the water's edge and enjoy the view, and our garden of remembrance.
3. End of Colton Street, water access. This grassy lane inclines towards our bay and has a small sandy beach. A good area to launch a canoe or kayak.
4. End of Archer Street, includes a level, paved ramp & pier

**CAUTION!!!** *Streets are narrow and we have a lot of children and adults out cycling and playing, please go slowly and be watchful at all times.*

**MEMBER BENEFITS** 5% of dues are used to sponsor community and civic activities. **MOSQUITO SPRAYING** is scheduled, each year, for evenings between June and September. Be sure to keep yourselves, your children, & your pets indoors while they are spraying. Spraying is provided by the MD Department of Agriculture and paid for by the association. Annual cost approximately \$3,000.

**NEIGHBORHOOD WATCH** Our community was the first to go online with the St. Mary's Sheriff's department as part of an email broadcast criminal notification system. While working in conjunction with the Sheriff's department our neighborhood has seen a decline in crime. Our success was written about in The Enterprise in regard-to “St. Mary's takes a bite out of crime”.
