



The Sunshine Coast Auto Recyclers extended warranty is in addition to our standard warranty inclusion supplied on all parts. Please refer to the standard warranty terms and conditions.

Extended Warranty Options

Sunshine Coast Auto Recyclers offers three different warranty options:

WARRANTY OPTIONS	DURATION PERIOD	INCLUSIONS
STANDARD WARRANTY	3 MONTHS	PARTS ONLY
GOLD WARRANTY	6 MONTHS	PARTS ONLY
PLATINUM WARRANTY	6 MONTHS	PARTS AND LABOUR ONLY

1. Sunshine Coast Auto Recyclers will not be responsible for freight/labour*/towing costs, accommodation, loss of income or downtime that may be a consequence from the use of sold parts. **Unless labour warranty is purchased.*
2. If there is an issue with an item purchased from Sunshine Coast Auto Recyclers it is the customers responsibility to cease operation and report immediately. Continued use beyond this advice will void all warranties.
3. All Parts returned for warranty or any other reason must be still complete as they were sold, not painted or altered. The warranty/refund/exchange will not apply if parts are altered, dismantled, painted or have been otherwise tampered with by a person not authorised by Sunshine Coast Auto Recyclers.
4. At its option, Sunshine Coast Auto Recyclers will repair, replace, or refund the purchase price of the defective part.
5. For items purchased with Labour warranty, a maximum of \$110.00 (incl. GST) labour rate is payable on any warranty claims. Publications such as times guide and dealer information, specifically Capricorn Auto Data repair times, will be used to determine and set maximum times for labour charges. All labour claims must be approved by Sunshine Coast Auto Recyclers prior to any works being started.
6. All engines supplied by Sunshine Coast Auto Recyclers are fitted with a heat tab. Warranty is void if the heat tab has been altered, removed or melted.
7. Engines and transmissions sold must be serviced as per manufacturer guidelines, if not serviced or incorrectly serviced may void warranties.
8. All engine and driveline seals must be replaced; oil or fluid leaks are not covered under warranty.
9. Modern transmissions require programming using dealership grade software, Sunshine Coast Auto Recyclers is not liable for the calibration of transmissions. It is a warranty requirement that new transmission service kits & fluids including oil coolers be fitted. (oil coolers on supplied transmissions is not tested and needs to be replaced with a new unit)
10. Warranty does not apply to accessories and non-standard inclusions or any part that is attached to the engine, including but not limited to turbo charges, switches, sensors, cables, electronics, belts, hoses, water pumps, oil seals and manifolds.
11. Warranty does not apply to transmissions, differentials and final drive components that have broken gears or have been subject to accident, misuse, neglect or use inconsistent with its intended purpose.

12. The warranty cover does not extend to damage caused by accident, misuse, neglect, natural disaster or act of God or other external causes or to damage caused by using the parts inconsistently from their intended purpose.
 13. We will not accept returns on cut sections or specially ordered parts.
 14. We will not be held responsible for any consequential loss or damage, loss of income or down time due to the failure of any part sold.
 15. All repairs made without the written authorization of Sunshine Coast Auto Recyclers will be the responsibility of the customer.
 16. Warranty starts from the invoice date shown on invoice.
 17. Warranty stays with the original purchaser on the tax invoice and cannot be transferred to another owner/customer.
