## NAMC SOLIDIFIES NATIONAL LEADERSHIP IN FEDERAL DIVERSITY AND INCLUSION AT 56TH ANNUAL CONFERENCE

Washington, D.C. – As federal programs supporting minority-owned businesses face intensifying legal challenges, the National Association of Minority Contractors (NAMC) is emerging as a vital force in defending and advancing diversity and inclusion across America's construction industry. At its 56th Annual National Conference, held June 17-19, 2025 in Cleveland, Ohio, in partnership with the NAMC Northern Ohio Chapter, NAMC reasserted its role as a national thought leader and policy advocate for inclusive economic growth, workforce development, and inclusionary contracting practices. Congratulations to Ariane Kirkpatrick, President of the Northern Ohio Chapter, for hosting such a powerful and purpose-filled event.

This year's conference theme, Unity: One NAMC - Building Equity and Protecting Our Future, underscored a bold stance amid growing political and legal threats to affirmative contracting. Over three days, NAMC convened industry leaders, elected officials, agency representatives, and contractors for high-level panels, business development workshops, and strategic networking. From the Women in Construction Luncheon to the Legacy Contractors Roundtable, NAMC demonstrated its unmatched capacity to bridge legal action, history, policy, practice, and advocacy.

TIME Magazine named Skye Perryman, President and CEO of Democracy Forward, to the 2025 TIME100 annual list of the most influential people in the world. Ms. Perryman attended the NAMC National Conference to recognize NAMC President Wendell R. Stemley for his leadership on the front lines in advocating for minority business participation in government and private contracting programs, working in collaboration with Democracy Forward Senior Counsel Brooke Menschel. As you may be aware, NAMC and its coalition partners are enjoined in the lawsuit Mid-America Milling Co. v. U.S. Department of Transportation. The coalition is represented by Democracy Forward, the Minority Business Enterprise Legal Defense and Education Fund (MBELDEF), and Wyatt, Tarrant & Combs LLP.

The Democracy Forward Team and Skye Perryman work tirelessly to safeguard our enduring, yet fragile, democracy. When Donald Trump's federal-funding freeze sparked fear and confusion across the country, Ms. Perryman mobilized a rapid-response legal team and filed the nation's first lawsuit challenging the freeze, winning the crucial administrative stay (and later injunction) that halted it nationwide.

Nevada Attorney General Aaron D. Ford, this year's keynote speaker, reaffirmed his commitment to protecting corporate diversity initiatives and combating efforts to roll back progress. He collaborated with NAMC in standing against a letter issued by 13 conservative state attorneys general that sought to intimidate Fortune 100 companies away from implementing lawful diversity and inclusion programs. In response, Attorney General Ford led a coalition of over 20 attorneys general in issuing a formal rebuttal, defending DEI efforts as both legal and essential to economic opportunity and diversity and inclusion in the workplace.

A central highlight of this year's conference programming was NAMC's spotlight on MBELDEF—the Minority Business Enterprise Legal Defense and Education Fund—the only national legal initiative solely dedicated to protecting the rights of minority contractors. With minority business programs increasingly targeted in court, MBELDEF plays a critical role in preserving access, ensuring fair representation, and providing rapid-response legal support.

MBELDEF is building a national Story Bank to document real-life discrimination in contracting, providing essential evidence for courts and Congress. MBELDEF is also actively raising funds to deploy legal teams where needed most. At the conference, attendees were encouraged to Tell your story. Support the fight. Show up. With this initiative, NAMC is leading the charge in turning legal resistance into legal resilience.
