- Approximately 38'-0" LF of upper cabinetry and 47'-0" of lower cabinetry.
- Providing all required submittals and shop drawings for architectural review prior to procurement.
- Furnishing and installing casework systems per the plans and specifications
- Submission of all submittals detailed in the specifications. This includes thorough review of details with complete understanding of scope
- Providing all LEED and sustainability documentation
- Procuring materials from specified manufacturer
- Coordinating installation with other trades as needed
- Completing installation per manufacturer recommendations and approved plans

3. Materials

This scope covers the installation of the following flooring systems: carpet tile, resilient base, walk off carpet tile, epoxy coating and sealed concrete. The subcontractor shall provide all labor, materials, equipment, and services necessary to complete the work in accordance with project requirements.

The subcontractor shall be responsible for:

- Providing all required submittals and shop drawings for architectural review prior to procurement
- Furnishing and installing flooring systems per the plans and specifications
- Submission of all submittals detailed in the specifications. This includes thorough review of details with complete understanding of scope
- Providing all LEED and sustainability documentation
- Procuring materials from specified manufacturer
- Coordinating installation with other trades as needed
- Completing installation per manufacturer recommendations and approved plans

1. Overview

This scope covers the installation of continuous wall-to-wall acoustical panel ceiling systems as indicated on the drawings, and as needed to meet the requirements of the construction indicated.

2. Scope of Services

The subcontractor shall be responsible for:

- Providing all required submittals and shop drawings for architectural review prior to procurement
- Furnishing and installing acoustical ceiling panels and exposed grid suspension systems complete with all handers, runners, tees, wall angles and trims
- Procuring acoustical panel and suspension materials from a single approved manufacturer (basis of design: Armstrong Ceiling and Wall Solutions)
- Coordinating ceiling layout with other trades as needed
- Installing ceiling systems in accordance with ASTM C636, manufacturer's written instructions, and approved plans
- Providing all LEED and sustainability documentation.
- Supplying required attic stock: minimum 5% extra acoustical panels and 2% extra exposed suspension components
- Completing installation per manufacturer recommendations

3. Materials

- Manufacturer: Armstrong Ceiling and Wall Solutions
- Product: Ultima 2X2 Acoustic Panels; Clean Room VL 868 Unperforated.
- All materials must meet specifications outlined in the contract documents and approved submittals.
