SR 167, I-5 to SR 161 New Expressway Project

Kraemer-Scarsella Joint Venture (KSJV) invites all subcontractors and suppliers, including small and diverse businesses, to submit bids for the SR 167/I-5 to SR 161 – New Expressway Project, a Progressive Design-Build project for the Washington State Department of Transportation (WSDOT). This project will deliver a new expressway corridor, including major roadway, bridge, and utility work, with a focus on safety, efficiency, and stakeholder collaboration.

Project Overview:

The SR 167/I-5 to SR 161 – New Expressway Project involves the design and construction of a new expressway to improve transportation efficiency and connectivity in the region. The project will complete the diverging diamond interchange at I-5 and work at SR 161 to include building a new half interchange at Valley Avenue. The project includes a large segment of the spuyaləpabš Trail, an auxiliary lane on southbound I-5, wetland mitigation sites, and a weigh-in-motion inspection building for the State Patrol.

The project will require compliance with all WSDOT standards, environmental commitments, and small and diverse business participation.

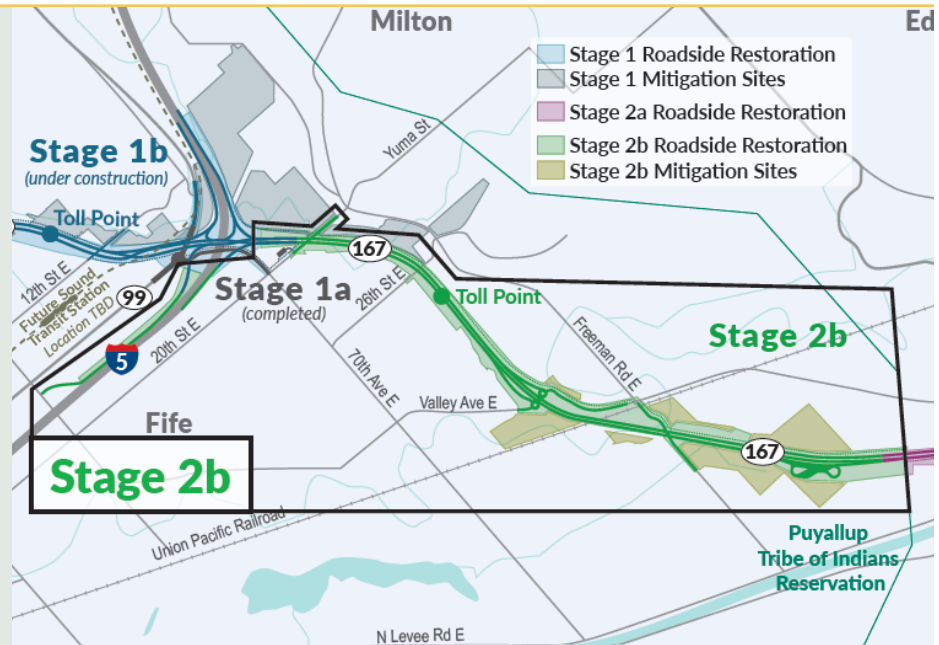
