The address belongs to Ms. Green's [redacted] and [redacted] who were on scene. [redacted] had taken [redacted] to the residence the previous night after he received a message from Ms. Green that she intended to [redacted] this morning at 0600 from his residence of [redacted] communicated with Ms. Green through a [redacted] that it was not her time with [redacted] and she could not pick him up. When Ms. Green refused to listen and continued to state she would be there in the morning, [redacted] decided to remove [redacted] from the home and take him to [redacted]

[redacted] stated that at 0645 hours, his [redacted] Ms. Green, arrived at the home. [redacted] exited his home and contacted Ms. Green in his driveway. [redacted] told Ms. Green that she was not allowed to be there and she needed to leave. Ms. Green yelled at [redacted] and refused to leave. Ms. Green then walked past [redacted] and entered his home through the front door. [redacted] followed Ms. Green into the home and repeatedly told her she needed to leave and she could not be there. Ms. Green refused to leave. [redacted] described being estranged from his [redacted] for over two years. Ms. Green did not live at the residence, did not have property there, and did not have a key.

Ms. Green grabbed [redacted] who was now crying. Ms. Green picked [redacted] up. [redacted] approached Ms. Green. [redacted] now observed Ms. Green had a black handgun on her hand, near her waist. [redacted] was alarmed and scared. [redacted] indicated she also observed Ms. Green with the handgun in her hand. [redacted] placed his hands up and took a step away from Ms. Green. [redacted] stated the weapon was never pointed directly at him, but he was afraid when he saw Ms. Green with the weapon because she was acting irrationally and has a history of Mental Health issues. Ms. Green was holding [redacted] with one arm and the gun with the other. [redacted] was squirming and crying, causing Ms. Green to move her body around which caused the weapon to be pointed in several different directions, including his direction. [redacted] had been placed down on the ground and ran away from Ms. Green. [redacted] was crying and telling Ms. Green that he did not want to go with her. Ms. Green holstered her firearm and went to [redacted] and forced him out the front door of the residence. [redacted] followed Ms. Green out the front door and observed as she forced [redacted] into the [redacted]
