



2023 MID-STREAM HEAT PUMP & HEAT PUMP WATER HEATER REBATE PROGRAM

PROGRAM DETAILS:

Rebate Program for High-Efficiency Water Heater and HVAC equipment sales to Puget Sound Energy, Seattle City Light, and Snohomish PUD Customers.

- Rebates for air-cooled heat pumps less than 5.4 tons and heat pump water heaters will be passed on to Contractors via Gensco’s Utility Rebate Claim Center available on GenscoCustomer.com (GenscoCustomer.com > [Product Resources](#) > [Power Utility Rebate](#) > [Washington](#) > [Claim Center](#))
- Seattle City Light and Snohomish PUD customers are eligible for only **ONE** AHRI rated system per household.
- Contractors are strongly encouraged to list the midstream rebate as a pass-through to the customer on their estimates and paid installation invoices in order to prevent Customer confusion

Makes and models of heat pump water heaters and air-cooled heat pumps meeting or exceeding the efficiency requirements, based on AHRI ratings listed in the tables, will qualify for Program rebates.



QUALIFYING AIR-COOLED HEAT PUMP:

Puget Sound Energy, Seattle City Light, and Snohomish PUD Customers are eligible for rebates effective January 1, 2023.

This Table is effective for equipment that only has SEER/HSPF ratings in the AHRI Directory with an invoice date between January 1, 2023–December 31, 2023 or for equipment that has both SEER/HSPF and SEER2/HSPF2 ratings in the AHRI Directory with an invoice date between January 1, 2023–June 30, 2023. Equipment meeting these criteria and invoice dates can be submitted to the Program at any time in 2023.

This table is effective for equipment that only has SEER2/HSPF2 ratings in the AHRI Directory with an invoice date between January 1, 2023–December 31, 2023. Equipment with both ratings with an invoice date between July 1, 2023 and December 31, 2023 will use criteria determined under the SEER2/HSPF2 ratings for this table as well. Equipment meeting these criteria and invoice dates can be submitted to the Program at any time in 2023.

QUALIFYING HEAT PUMP WATER HEATERS:

Puget Sound Energy, Seattle City Light, and Snohomish PUD customers are eligible for rebates effective January 1, 2022.

PROGRAM PROCESS:

Rebate amounts, qualifying efficiencies, and the application process are unified across Seattle City Light, Puget Sound Energy and Snohomish PUD service areas to make participation as simple as possible.

- Rebates will be paid to Gensco on proof of Contractor sale of qualifying high efficiency equipment (see tables below). Gensco will pass these incentives on to Contractors after proof of a qualifying installation is provided via the GenscoCustomer.com Utility Rebate Claim Center
- Requirements for reimbursement:
 1. Rebates must be clearly listed on the contractor invoice
 2. Rebates are intended to reduce the price of the equipment for the Customer
 3. Claim must be entered on GenscoCustomer.com Utility Rebate Claim Center
 4. It is the responsibility of the Contractor to provide a properly matched AHRI system that qualifies for the selected HSPF rebate level. **Any claim received that does not qualify per Puget Sound Energy or Seattle City Lights requirements will be charged back directly to the Contractor's Gensco account.**

Puget Sound Energy, Seattle City Light, and Snohomish PUD will advertise the availability of these rebates to customers.

Sales resources and on-going support will be available via Gensco, in coordination with the Energy Solutions Team.

ELIGIBLE PARTICIPANTS:

Equipment cannot be installed outside of Puget Sound Energy service areas:

- Contractors purchasing qualifying HVAC and heat pump water heater equipment must be installing equipment on behalf of customers with a valid electric service account with Puget Sound Energy, Seattle City Light or Snohomish PUD
- Contractors must verify that their customer is a Puget Sound Energy, Seattle City Light or Snohomish PUD electric customer to ensure eligibility. Contractors will need to provide the customer's service address when purchasing qualifying equipment
