This was a year of remarkable accomplishment and growth for MiraVia. First, we are proud to announce that MiraVia achieved the status of national accreditation! This award from the world-renowned Council on Accreditation certifies that MiraVia meets the highest professional standards in every aspect of operations; from governance and finance to program services and ethics. Accreditation by the COA is a milestone that was two years in the making, and we are honored to provide the level of service worthy of this recognition.

Perhaps even more remarkable was the baby boom at MiraVia's residential program this year! We welcomed the births of seven babies, including six boys and one girl. Each baby is healthy, happy and thriving. We look forward to January when another baby girl is due, bringing us to eight babies in the house. The residence is filled with laughter and love as these mothers and children embrace each other and the new lives they will lead.

At the same time, MiraVia's Outreach Program in Charlotte provided life-changing help to more than 500 women and children who lacked the food, clothing and family support that most of us take for granted every day. The pregnant mothers in this program join bi-weekly support groups at MiraVia where they receive groceries, diapers, clothing, baby goods and essential life-skill classes that bring hope in a time of despair. 100% of these women reported that MiraVia improved their parenting knowledge and quality of life.

As we look back on all of this growth, I want to thank you for making it possible. I can't wait to see what we can achieve together next year!

★ Our Mission

Respecting and affirming life from the moment of conception, MiraVia is a safe haven and source of hope for pregnant mothers and their children. Invoking a Christ-centered approach inspired by the examples of Mary and Joseph, MiraVia helps young families move toward a new life of hopeful, independent, and healthy living and educates the broader community on the importance of fostering a culture of life.

★ Our Credentials

MiraVia, Inc. is a 501(c)(3) nonprofit corporation operating in Charlotte, North Carolina. It was incorporated as Room At The Inn, Inc. by the Secretary of State in March 1994 and licensed by the North Carolina Department of Health and Human Services. The organization was rebranded as MiraVia in 2013. Since the first pregnant mother's admission in December of 1994, the residential program has served 535 mothers and children. The nonresidential outreach programs, established in July 2004, have served more than 8,060 mothers and children. MiraVia is a ministry of the Catholic Church and is listed in the P.J. Kenedy and Sons Official Catholic Directory. Pregnant women are served regardless of their economic, social, religious, racial or ethnic background.

★ Our Services

MiraVia's services provide hope and help not only to enable pregnant women in need to choose life for their baby but also to provide a future for that young life. Always mindful of our Catholic foundation, all programs are developed with a "Christ-centered" approach. Integrating emotional and material assistance as well as practical programmatic and life-skills support, both outreach and residential programs invest in the healthy futures of the mother as well as her child. No other regional program provides such extensive care.

College-based Program...
“the next step in pro-life service...”

MiraVia’s College-Based Program is specifically designed to meet the needs of pregnant college women, integrating both prenatal and postnatal services. Providing for the most abortion vulnerable population – pregnant college students – the residence in Belmont, North Carolina is equipped to house young mothers during their maternity and after their baby is born for a total of 24 months. Housing, meals, professional counseling, professional case management, infant clothing and supplies, and extensive life-skills training in parenting, personal finance, nutrition, infant care, adoption options, and employment basics are all included free of charge. To be admitted to this program, mothers must be 18 years or older and an active student at a college or university. The primary objectives of this innovative program is to empower young mothers to choose life for their child, whether they choose to parent or allow someone else to parent their child through adoption, and to achieve their educational and professional goals. The MiraVia College-Based Program has been hailed by national pro-life leaders as “the next step in pro-life service.”

Outreach Program...
“bringing hope to those who have little...”

Focusing on pregnant women in need, the Outreach Program provides meaningful material, emotional, and programmatic support in both English and Spanish. Participants receive maternity clothes, baby clothes, diapers and baby furnishings, food, and many other household necessities. By attending bi-weekly program sessions for up to a year, these mothers learn about health, parenting, nutrition, relationship building, ESL and a variety of other topics and community resources. Each mother builds a support community to rely on as she moves beyond this program. Both teen and adult mothers qualify for this free program.
