Our College Residence at Belmont Abbey College and Outreach Center in Charlotte are united in one purpose: to protect the sanctity of life. Each program is unique in what we offer to mothers and their children, and both provide unparalleled long-term support. These services have been made possible by the generosity of friends like you....some who are brand new to this pro-life work and others who have been with us since the beginning. On behalf of all those we serve, *thank you.*

Last year, *you helped 20 mothers and children* to live in a nurturing home on campus as moms continued their college education. Meals, childcare, life-skills classes and weekly case management empower young women as they create plans for a successful future.

*You also provided 702 mothers and children* with diapers, groceries, clothing and household items through our Charlotte Outreach Center. We meet low-income families' basic needs for a full year as moms attend bi-weekly classes on parenting, health, child safety, and financial planning.

## ★ Our Mission

Respecting and affirming life from the moment of conception, MiraVia is a safe haven and source of hope for pregnant mothers and their children. Invoking a Christ-centered approach inspired by the examples of Mary and Joseph, MiraVia helps young families move toward a new life of hopeful, independent, and healthy living and educates the broader community on the importance of fostering a culture of life.

## ★ Our Credentials

MiraVia, Inc. is a nationally-accredited 501(c)(3) nonprofit corporation operating in Charlotte, North Carolina. It was incorporated as Room At The Inn, Inc. by the Secretary of State in March 1994 and licensed by the North Carolina Department of Health and Human Services. The organization was rebranded as MiraVia in 2013. Since the first pregnant mother's admission in December of 1994, the residential program has served 587 mothers and children. The nonresidential outreach programs, established in July 2004, have served 9,901 mothers and children. MiraVia is a ministry of the Catholic Church and is listed in the P.J. Kennedy and Sons Official Catholic Directory. Pregnant women are served regardless of their economic, social, religious, racial or ethnic background.

## ★ Our Services

MiraVia's services provide hope and help not only to enable pregnant women in need to choose life for their baby but also to provide a future for that young life. Always mindful of our Catholic foundation, all programs are developed with a “Christ-centered” approach. Integrating emotional and material assistance as well as practical programmatic and life-skills support, both the residential and outreach programs invest in the healthy futures of the mother as well as her child. No other regional program provides such extensive care.

## College-Based Program...

**"the next step in pro-life service..."**

MiraVia's College-Based Program is specifically designed to meet the needs of pregnant college women, integrating both prenatal and postnatal services. Providing for the most abortion vulnerable population – pregnant college students – the residence in Belmont, North Carolina is equipped to house young mothers during their maternity and up to 24 months after the baby is born. Housing, meals, professional case management, infant clothing and supplies, and extensive life-skills training in parenting, personal finance, nutrition, infant care, adoption options, and employment basics are all included free of charge. To be admitted to this program, mothers must be 18 years or older and an active student at a college or university. The primary objective of this innovative program is to empower young mothers to choose life for their child, whether they choose to parent or allow someone else to parent their child through adoption, and to achieve their educational and professional goals. The MiraVia College-Based Program has been hailed by national pro-life leaders as "the next step in pro-life service."

## Outreach Program...

**"bringing hope to those who have little..."**

Focusing on pregnant women in need, the Outreach Program provides meaningful material, emotional, and programmatic support in both English and Spanish. Participants receive maternity clothes, baby clothes, diapers and baby furnishings, food, and many other household necessities. By attending biweekly program sessions for up to a year, these mothers learn about health, parenting, nutrition, relationship building, ESL and a variety of other topics and community resources. Each mother builds a support community to rely on as she moves beyond this program. Both teen and adult mothers qualify for this free program.
