

PRESIDENT'S MESSAGE

September 11, 2001 - NEVER FORGET

Hello everyone and welcome back from our summer break. It's incredible how we look forward to the summer months and they seem to go by in the blink of an eye. As we have all enjoyed the summer months, let's not forget the dangers of being a police officer. On Monday, July 28th Police Officer Didarul Islam was aunned down on Park Avenue in Manhattan. In what appears to be an attempted act of vengeance on the NFL an individual entered 345 Park Avenue just after 6:30pm carrying an AR-15. PO Islam was working a security detail and was gunned down along with four others and another was left injured. PO Islam served three and a half years with the NYPD and leaves behind a wife, two children and an unborn child. He was posthumously promoted to Detective 1st grade. May his soul and the souls of all the faithfully departed rest in peace.

It truly is a shame when a police officer is killed in the line of duty. Nobody expects it to happen but reality is, when we put our uniforms on, stand roll call and turn out, it's a possibility we won't be signing out at the end of our tour. Very bad scenario, but a possibility. What bothers me more is when a MOS takes their own life. It's happened too many times and already way too often this year. Please, if you know someone going through tough times please reach out. We have one of our members Ed Patterson and good friend Steve Mauriello who will be more than happy to help. Unfortunately the bad news continues. As you are all well aware the NYS Court of Appeals has reversed every lower court's decisions and sided with the City in our Medicare battle. I'm not a conspiracy theorist, but something is fishy about this decision. I personally think

the fix was put in, but that's just my opinion. Mayor Adams has said that he is not going to force retirees into Medicare Advantage, "at this time". Let's see what happens after the November elections. Now there's another mess. FAREWELL

Tradition calls it a "swan song." a phrase for a final gesture or effort given just before retirement. I have no such thing to contribute, but I can say something about the word "fare well" as I conclude my time as one of the chaplains for the Long Island Shields!



Chief John Aresta has been involved in Public Safety for over 43 years beginning as a Volunteer Firefighter with the Malverne Volunteer Fire Department in 1982 and then in 1984 working as an EMT for the NYC Emergency Medical Service out of Coney Island Hospital.

He began his law enforcement career 36 years ago by becoming a NYC Police Officer in 1986. He was assigned to training in NSU 12 and when he completed NSU, he was assigned to the 71st precinct in Brooklyn. In 1990 he joined the Malverne Police Department. Chief Aresta rose through the ranks of the Malvern Police Department where he started as a police officer, was promoted to sergeant then lieutenant. In 2006 he became the Malvern Chief of Police. Chief Aresta retired from the Malvern Police Department in December 2024 after serving as Chief for over 18 years.

During his career Chief Aresta had the opportunity to become a certified Crime Prevention Officer, a Motorcycle Officer and a DCJS instructor. He was also fortunate to attend and graduate the 24th session of the FBI Leeds class at Princeton University. In November of 2022 he was appointed to the FBI's Criminal Justice Information Services Advisory Policy Board by FBI Director Christopher Wray.

He is currently the Past President of the New York Association of Police Chiefs after proudly serving as President from 2018-2019 and he now remains on the Board of Governors for the Association

The Chief is also a Past President of the Nassau County Municipal Police Chiefs Association having served there from 2020-2021, as well as President of the Nassau County Police Asian Jade Society since 2010.

While he was Chief of Police he was fortunate to be able to make sure that the Police Officers had the best equipment and training to do their jobs. During his tenure he was able to implement such programs as in car computers, in car video, TRACS ticketing system, Tasers, M-4 rifle training, narcan training and most recently prior to retiring he was able to ensure that all Officers were trained and equipped with Epi-pens and Life-vac equipment.

One of the many highlights of the Chief's career was the conception, design, building and opening of a new state of the art Police Headquarters which opened in September of 2024. This building is a testament to the hard work and dedication of the men and women of the Police Department as well as the cooperation and support from the Mayor and Village Board.

After a long and exemplary career, the Long Island Shields proudly salute Chief John Aresta and wish him a long and healthy retirement. Congratulations Chief, well deserved.

GOOD TO KNOW

Starting college can be a very emotional experience for both the child and the parent, especially if this is the first time the child will be living on their own. Certain safeguards should be taken to protect your child, their property and your investment.

Health Care: Through the Affordable Care Act, a dependent child can remain on a parent's health insurance plan until age 26. This can be particularly beneficial if the parents' health plan has providers where the child attends school. plan does not have network providers near the school then check the plan's out-of-network coverage to evaluate possible costs. New York State also has a "Young Adult Option" that allows eligible dependents to purchase coverage through their parents' plan until age 29, under certain conditions.

Another source of coverage comes from the school, which provides access to student health plans. In some cases, schools automatically put students in their health plans unless the student or their parents prove that coverage already is in place. The out-of-pocket copays and deductibles for these plans can be lower than their parents' plan. Should you decide on a student plan, review it to see how much the premiums are and how much coverage is provided.

Property Protection: Parents may not be aware that homeowner's insurance can extend some protection to their children going away to college. Approximately 10% of the personal property coverage on your policy (also known as "Coverage C") will cover possessions in a child's dorm room. So, if the Coverage C on your policy was \$500,000, \$50,000 would be afforded if a covered loss were to occur. If your child resides off-campus, then they

should secure renters' insurance, which covers their possessions from theft, fire, vandalism, and other types of damage. Renter's policies typically also provide liability coverage to pay legal bills for accidental injuries to someone or damage to someone else's property. (Intentional acts aren't covered.)

Expensive items such as computers and other technology are often subject to coverage limits under a standard homeowner's policy. If the limits are too low, consider purchasing a special personal property endorsement.

Tuition: Since you are paying a significant amount of money in college tuition and fees, you might consider tuition insurance. This type of insurance can provide reimbursement for tuition, fees, room and board if a student withdraws because of an injury or illness, such as a serious or chronic illness, mental health condition or substance abuse.

Before the start of classes, ask the college for their refund policy and if they offer tuition insurance.

Taking some of these basic precautions to have adequate coverage for your child while away at college will more likely make it a better and less worrisome experience for both you and your child.
