Election Procedures

Vote by Proxy or In Person!

- 1. Candidates <u>MUST</u> be a resident-shareholder/tenant of record at Esplanade Gardens at least 18 years old.
- 2. Candidates <u>MUST</u> be a shareholder of record not less than one year prior to the Annual Stockholders Meeting. (Name on both Stock Certificate and Occupancy Agreement).
- 3. Candidates <u>MUST</u> be in good financial standing with the Corporation:
- (i) Not shown in the Corporation's books or Management accounts to be delinquent in the payment of any monthly carrying charges/maintenance or any other charges as of the date said candidate is nominated; and
- (ii) during the prior twelve months from the month in which the meeting is held, not have been delinquent in the payment of any such monthly carrying charges/maintenance (for eligibility purposes, delinquent shall mean that payment of any monthly carrying charges/maintenance or other charges was made later than the last day of the month for which they were due).
- 4. Candidates may self-nominate.
- 5. No candidate, cooperator or any other person is to interfere with the company handling the election.

- 6. All candidates are asked to attend the Annual Stockholders Meeting in person on Sunday, October 27, 2024 at 2:00 p.m.
- 7. The election polls will end at 6:30 p.m. No one will be allowed to vote after 6:30 p.m. The doors will be locked and the Election Company is in control with respect to the polls and the tally and may not be interrupted.


KEBRA HUTTON BUILDING 2

Campaign Restrictions

- A. NO loitering in the hallways or grounds of the North Community Room at Esplanade Gardens on the day of the election shareholders who intend to vote in person must wear a mask, maintain social distance, bring VALID photo ID, and be prepared to wait in line as the number of people allowed in the South Community Room will be limited.
- B. NO CAMPAIGNING, ELECTIONEERING WITHIN 100 FEET OF THE VOTING AREA.
- C. NO signs or literature shall be posted on grounds or elevators.
- D. Palm cards should be no larger than 5" x 8".
- E. Shareholders, including candidates, may only enter the voting area (i.e., the South Community Room) to deliver a proxy or to vote, and must exit the South Community Room as soon as their vote has been cast (or the proxy delivered). There will be NO LOITERING. If there are problems or questions, they should be discussed with the Election Committee outside of the South Community Room.
- F. The Election Committee cannot campaign for any candidate.
