In addition a copy of the notification and this letter shall be conspicuously posted in a public space on the ground floor of each building affected. Copies of the notice to the shareholders shall also be kept available for inspection by any shareholder requesting a copy. Satisfactory proof of notification to shareholders must be supplied to HPD not less than 10 days prior to the date for the hearing.

Please note that HPD reserves the right either to concur with the requested increase, or in the alternative, to order any appropriate increase that it determines is necessary in order to achieve the desired economic stability of this housing company.

For an increase of the maximum average monthly carrying charges from the present maximum average base monthly carrying charges (including utilities) of \$201.06 per room to \$222.17 per room (10.5 %) in the first year, from \$222.17 per room to \$229.95 per room (3.5%) in the second year and from \$229.95 per room to \$237.99 per room (3.5%) in the third year based on then current finances, pursuant to the provisions of Article 2 of the Private Housing Finance Law.

PLEASE TAKE NOTICE, that upon the annexed application of ESPLANADE GARDENS, INC. ("Esplanade") to the New York City Department of Housing Preservation and Development ("HPD"), HPD will be requested to approve an increase in the maximum average monthly carrying charges, including utilities, in the housing development of Esplanade from the present maximum average monthly carrying charges of \$201.06 per room to \$237.99 per room, to be implemented in three stages as follows: in the first year, from \$201.06 per room to \$222.17 per room (10.5 %), in the second year from \$222.17 per room to \$229.95 per room (3.5%), and in the third year, from \$229.95 per room to \$237.99 per room (3.5%) depending on the financial circumstances as determined by the Board of Directors of Esplanade at that time.
