

RELEASE OF LIABILITY AND INDEMNITY AGREEMENT

As valid consideration for entry into and participation in the EASTERN BRAHMAN EXTRAVAGANZA BRAHMAN SHOW AND SALE (the "Show") the undersigned hereby enters into this RELEASE OF LIABILITY AND INDEMNITY AGREEMENT (this "Agreement").

ACKNOWLEDGEMENT OF RISKS: The undersigned recognizes and understands there are risks associated with entry into and participation in the Show including, but not limited to, bodily injury or death, and damage to property or privacy rights. The undersigned further acknowledges that they will be liable for all damages to persons, livestock, or property that is caused by them or any persons (including, but not limited to, minors) under their care and control, and that arise out of, or are related to, the undersigned's entry into and participation in the Show.

WARNING: UNDER CHAPTER 12 OF TITLE 4, GEORGIA CIVIL PRACTICE AND REMEDIES CODE, A LIVESTOCK SHOW SPONSOR IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN A LIVESTOCK SHOW RESULTING FROM THE INHERENT RISKS OF LIVESTOCK SHOW ACTIVITIES.

COVID-19 WARNING-ASSUMED RISK: BY ATTENDING THE SHOW, YOU VOLUNTARILY ASSUME ALL RISKS RELATED TO EXPOSURE TO COVID-19. An inherent risk of exposure to Covid-19 exists in any public place where people are present. Covid-19 is an extremely contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and individuals with underlying medical conditions are especially vulnerable. RELEASE FROM LIABILITY: The undersigned hereby releases, acquits and forever discharges and agrees to defend, indemnify and hold harmless the Eastern Brahman Breeders Association (EBBA), their present and former members, directors, board members, officers, employees, agents and representatives and the respective heirs, administrators, executors, successors and assigns and any other person, firm or corporation (collectively the "EBBA Parties") from any and all claims, causes of action, suits and/or demands for personal injury, death or property damage, accrued or to accrue in the future, known or unknown, (collectively, "Claims") relating to or arising out of any negligent, grossly negligent and/or intentional or unintentional acts on the part of the undersigned in connection with entry into and participation in the Show. Without limiting the foregoing, the undersigned agree that the EBBA Parties shall not be liable to them, their family, heirs, administrators, executors or assigns for Claims arising from or related to the undersigned's entry into and participation in the Show. As used herein, "INDEMNIFY" means to agree to assume the EBBA Parties liability in a situation, thereby relieving them of responsibility and/or reimbursing the EBBA Parties for Claims asserted against them.

VOLUNTARY CONSENT: As further inducement to EBBA to permit the undersigned's entry into and participation in the Show, the undersigned represents that he/she thoroughly and completely understands that this is a complete and final release and indemnity agreement, that he/she is freely and voluntarily entering into this Agreement, and that no representative of a EBBA Party has influenced the undersigned in causing him/her to sign this Agreement. The undersigned understands that this Agreement shall be binding on his/hers heirs, executors, successors and assigns, that this Agreement will be governed by the laws of Georgia, if any part of this Agreement is determined to be invalid or unenforceable, it does not affect the validity of the remainder of this Agreement. The undersigned agrees to the terms and conditions above and acknowledges receipt of this Agreement.
