Agenda item:

Determine the order of competition for the age divisions and/or competitive divisions as

required by Rules & Policies (R&P)

### **Discussion:**

Competitive divisions are the Xcel and JO levels. The SAC does not have a list of age divisions established from the previous season and State Administrative Committee Chairman (SACC) during discussion. Therefore, data will need to be reviewed before decision determined. Order of competition will be by random draw. Need to designate one (1) board member to work with State Meet Referee in conducting the draw to determine the competition order that each division/session will compete so we do not have numerous email(s) and meetings to determine and to improve efficiency.

#### Conclusions:

Sessions will be determined by the SAC based on division entries. Competitive divisions are the Xcel and JO levels. The order of competition within each session will be done by division (keeping levels within each division grouped together) and then random draw by gymnast. Brianne Rauzi is going to work on age divisions before next meeting based on State data. Donna Hunter will be the designated board member to work with the State Meet Director on establishing the competition order or draw for each division/session.

**Agenda item:** Overall Team Award for Wyoming State Championship

# **Discussion:**

Do we award an overall team for state or drop this award?

# **Conclusions:**

The state will maintain the Overall Team Award. In order for a gym to participate for the Overall Team Award, the gym must have a minimum of four (4) levels, two (2) levels in compulsories and two (2) levels in optionals. The four (4) highest All-Around (AA) scores of the gym in compulsories and/or optionals are added together to come up with the Overall Team Award score. However, only one (1) All-Around (AA) score from each level can be used to calculate the Overall Team Award. Example, two (2) JO program Level 3's All-Around scores could not be used to calculate the Overall Team Award, only the one (1) highest JO program Level 3 All-Around (AA) score can be used in calculating the Overall Team Award.

Agenda item: Gymnast Entry Fees for Wyoming State Championship

#### **Discussion:**

The 2017-2018 State Championship entry fees were seventy-five dollars (\$75.00) for all programs (Xcel and JO) and levels. Do we want to raise them to match Rules & Policies (R&P)?

### **Conclusions:**

Raise Wyoming State Championship entry fees for the 2018-2019 season to the maximum allowed by R&P:

- 1. Xcel, maximum being \$75 (Bronze, Silver, Gold) (R&P 2017-2018 P. 59 & 71)
- 2. Xcel, maximum being \$85 (Platinum & Diamond) (R&P 2017-2018 P. 59 & 71)
- 3. JO Compulsory, maximum being \$75 (R&P 2017-2018 P. 90)
- 4. JO Optionals, maximum being \$85 (R&P 2017-2018 P. 90)

**Agenda item:** Spectator Entry Fees for Wyoming State Championship
