GENERAL CONDITIONS FOR USE OF THE CROSS COUNTRY COURSE FOR CLINICS

- All bookings for the cross country course must go through the Capel Horse and Pony Club Cross Country Booking Officer. Please email rachhht@yahoo.com.au, and cc
 capelponyclub@outlook.com and capelponyclub@outlook.com
- All riders must be a member of either Pony Club WA or Equestrian WA.
- Riders can not use the course until all booking arrangements have been completed.
- Approved helmets and back protectors must be worn by all riders whilst mounted on a horse.
- Capel Horse and Pony Club reserve the right to close any jump/s at their discretion.
 The booking officer or delegated authority will confirm which jumps are/are not able to be used.
- Preserving the integrity of the ground surface on the approach and get away MUST BE A PRIORITY. Jump complexes are not to be overused. Clinic situations must have a responsible person on the ground, to notify the coach of surface becoming loose or dug up.
- Somebody with a current First Aid Certificate must be on the grounds when riding at all times.
- Participants can only bring the horse that they have registered for the clinic onto the grounds. No other horses are permitted.

GENERAL CONIDIONS OF USE OF CREP GROUNDS

- No horse is to be left on the grounds unattended.
- Camping is available at an additional fee of \$5 per person per night or \$10 per family per night, which includes the use of the clubroom amenities.
- All manure must be removed from the yards and float area left clean. Please do not put manure around the trees.
- Dogs are strictly not permitted, no matter their size. If you bring a dog you will be asked to leave the grounds, and forfeit fees paid.

GENERAL CONITIONS FOR THE COACH

- A bond of \$500 is payable upon booking, and refundable once the course has been checked. Contact will be made within 7 days after the clinic. If jumps are not raked, or jumps are broken, then the cost of repairs will be taken out of the bond.
- A minimum of 15 horse/rider combinations, a maximum of 25 horse/rider combinations per day.
- Non Capel Horse and Pony Club members cost is \$45 per horse/rider combination (which includes ground fee to be paid to CREP).
- Capel Horse and Pony Club members must be invited to attend in the appropriate classes, however they only need to pay the CREP ground fee (which at this moment is \$5).
- Coaches must have their own insurance in place, and a copy issued to Capel Horse and Pony Club with the booking form.
- Should a coach ride/school their own horse during the booked sessions, a fee of \$45 is still applicable.
