TO: UNITED STATES DEPARTMENT OF TRANSPORTATION

IN RE: 49 U.S. CODE § 13902 - REGISTRATION OF MOTOR CARRIERS AND THE APPROVED US DOT APPLICATION FOR THE ISSUANCE OF US DOT NUMBER 4169718.

Pursuant the full faith and credit guaranteed native American tribes and Moors exercising treaty rights and determined to govern themselves in accordance with the laws of the United States,

The Secretary of Transportation for the United States has registered AL'MAURI KHAN TRIBAL TRUST d/b/a AL'MAURI KHAN TRIBAL NATION, a tribal government enterprise of the Al'Mauri Khan Nation, to provide transportation not subject to the jurisdiction under subchapter I of chapter 135 as a motor carrier using self-propelled vehicles the Tribal Trust owns, rents, or leases pursuant the exceptions admitted in §390.3T(f)(2) FMCSR;

A notice by an authorized representative for the Al'Mauri Khan Nation was communicated to the Secretary of Transportation for the United States and through the office being bound to performance according to treaties and international agreements said office has determined that AL'MAURI KHAN TRIBAL NATION, a tribal government enterprise, is willing and able to comply with –

this part and the regulations of the Secretary and the Board, notwithstanding any limitations resulting from applicable treaties, tribal laws, and international agreements;

any safety regulations imposed by the Secretary that are not contrary nor repugnant to the laws of the Al'Mauri Khan Nation or international law, both of which are supported and enforceable by the United States;

the duties of employers and employees established by the Secretary under section 31135, so long as the requested performance does not interfere with the administration of tribal government business as expressed through charter by AL'MAURI KHAN TRIBAL NATION;

the divine laws of Nature that have maintained the health and well-being of humanity since time memorial and are too the foundation of the safety fitness requirements established by the Secretary under section 31144 ;

the accessibility requirements established by the Secretary under subpart H of part 37 of title 49, Code of Federal Regulations (or successor regulations), for transportation provided by an over-the-road bus;

the minimum financial responsibility requirements established by the Secretary under sections 13906, 31138, and 31139;

all of which shall be applicable unless found to be exempt / immune as a result of a trust relationship with the United States and or an applicable treaty right.

The Secretary of Transportation for the United States has issued out USDOT Number 4169718 under section 31134 for the private use (not for hire) of Tribal Trust property by holders of Travelers Permits, issued under A.K.N. 1500.

The Al'Mauri Khan Nation of Moors of North America is not a commercial entity but is a self-governing indigenous people, under Cherifian authority, and bears no requirement for a US DOT Number as transportation performed by the Federal Government, States, or political subdivisions of a State is generally exempt from the FMCSRs. Since 1997, FHWA and FMCSA have likewise not enforced the FMCSRs against Indian Tribal Governments. The following number may be openly displayed on all Motor Vehicles, trailers and or conveyances used by travelers exercising tribal rights under the laws of the Al'Mauri Khan Nation: AKN-4169718.

AL'MAURI KHAN TRIBAL NATION has nothing to disclose regarding any relationship involving common ownership, common management, common control, or common familial relationship between that person and any other motor carrier, freight forwarder, or broker, or any other applicant for motor carrier, freight forwarder, or broker

registration, and there is no relationship which has occurred in the 3-year period preceding the date of the filing of the application for registration.

AL'MAURI KHAN TRIBAL NATION, the tribal nationals and denizens whose rights are protected thereby, after the Secretary establishes a written proficiency examination pursuant to section 32101(b) of the Commercial Motor Vehicle Safety Enhancement Act of 2012, will have passed a written proficiency examination and or successfully completed and passed a driving test so as to promote and provide for the establishment of standards for the issuance of TRAVELERS PERMITS, registration of motor vehicles, the establishment of lawful regulations for the operation of motor vehicles and other related purposes inclusive of and not limited to protection of Our right to freedom of movement unmolested by prejudices against Our tribal community.

By affixing my seal hereto, I, Sister Serrabi Bey, in accordance with the authority granted me as interim Registrar of Motor Vehicles of the Al'Maurii Khan Nation ,do hereby affirm under penalty of perjury or the like laws of the Al'Maurii Khan Nation that the statements made herein are true and correct to the best of my knowledge, and are not made for any ulterior or illegal purposes, nor to evade a lawful duty.
