The lands of the Al’Maurii Khan are trust lands of the Moorish empire, of which Europeans are custodians over, having commercial rights and privileges under treaty law. Specifically, the Treaty of Verona, the Magna Charta, the 1787-1836 U.S. – Morocco Treaty of Peace and Friendship, the 1835 Camp Holmes Treaty, the 1848 Treaty of Guadalupe Hidalgo, the Geneva Convention, and many more.
The geographical location and boundaries of the old Moorish dominions are as follows: 43° North Latitude and 77.5° West Longitude – Northwest of the Atlantic Coast, on the continent of America [Atlantis], bound between Al’ Aksa and Cartagina [Carthage] to Argentina [Patagonia], inclusive of multiple territories within that boundary, this is based upon polar projection geometry, plane and spherical trigonometry of the Piri Rei’s Map, with lines radiating from Egypt, at the intersection of the Tropic of Cancer, with the Meridian of Alexandria, at 23° 30’ North, 30° East, and further described with the Holy Moorish – Circle 7 Koran, Ch. 47 Pgs. 57 – 59.

I am: Sagamore: brother brion heru'el ofrika bey el shayek yopaat, natural born aborigine blood of the Al'Maurii Khan Tribal Nation, descendant of Al'Maurii Khan Ancestors (the Ancient Ones / Moors¹ / Paleo-American tribes) of North America, Turtle Island (Northwest Amexem). This Notice brings forth the legal and lawful standing and status of the Al'Maurii Khan Nation (of Moors) / native American Aborigine [Indians], previously filed with Christopher Clark Deschene, Director of Tribal and Intergovernmental Affairs, Office of Congressional and Intergovernmental Affairs, U.S. Department of Energy via Certified Mail No. 70150920000107065069 September 2015 and reestablished by the bloodline of their Ancestors, the Ancient Ones, now filed with / in your records and or office for the purpose of **official notification of aborigine and tribal standing and the Treaty rights attached thereto.**

This is lawful Notice and is being filed pursuant Ancient Law Maxims, Divine Law, International Law, and further supported by 25 U.S. Code §194, §202, §371, Colorado Constitution Article II Bill of Rights Section 2 to your promise and your institutions policy to uphold the First, Fourth, Fifth, Sixth, Seventh, Ninth and Tenth Amendments and I, IV, and VI Articles of the Constitution for the United States of America Republic, and pursuant to your Oath, requires your written response specific to subject matter. Your failure to respond, as stipulated, and rebut, with particularity, everything in this Notice with which you disagree, is your lawful, legal and binding agreement with and admission to the fact that everything in this Notice is true, correct, legal, lawful and binding upon you and your agency, i.e. United States Department of Energy, Department of Interior and Bureau of Indian Affairs in any court of law, without your protest or objection or that of those who represent you. Your silence is your acquiescence to the truth and evidence of the Constructive Notice. See: Connally v. General Construction Co., 269 U.S. 385, 391. Notification of legal responsibility is "the first essential of due process of law". See also: U.S. V. This honorable, respectful, and proper (revised / updated) **"Constructive and Public Notice"** formally and further initiates the genuine efforts of the Al'Maurii Khan Tribal Nation to engage and establish its lawful, political, and legal status, intentions, and standing with regard towards coexisting within the territorial boundaries established as the United States.

EXCERPT FROM CHARTER:

We the people of Al'Maurii Khan Nation of Northwest Amexem / Turtle Island also known as North America are Moors. The lands of the Al'Maurii Khan Nation are trust lands of the old Moorish empire, of which Europeans are custodians over, and with commercial rights and privileges under treaty law.

The geographical location and boundaries of the old Moorish dominions are as follows: 43° North Latitude and 77.5° West Longitude – Northwest of the Atlantic Coast, on the continent of America [Atlantis], bound between Al'Aksa and Cartagina [Carthage] to Argentina [Patagonia], inclusive of multiple territories within that boundary, this is based upon polar projection geometry, plane and spherical trigonometry of the Piri Rei's Map, with lines radiating from Egypt, at the intersection of the Tropic of Cancer, with the Meridian of Alexandria, at 23° 30' North, 30° East, and further described with the Holy Moorish – Circle 7 Koran, Ch. 47 Pgs. 57 – 59.

Whereas, the **AL'MAURI KHAN NATION**, part and parcel of old Moorish Empire (Moabites, Canaanites, Hittites, Amorites,...) whose dominion and authority extended across the Great Aethiopic (Atlantic) OCEAN unto present day North, South, Central America, and the adjoining islands before the great earthquake which caused the Atlantic ocean as further affirmed in Ch. 47 of Moorish Circle 7 Koran, is herein acknowledged as Autochthonous American, a tribe of Sacred Aborigine People to the land inhabiting territory of the Americas of Turtle Island aka Northwest Amexem by the filing of "Tribal Trust Notice" filed with the United States Department of Energy, Tribal and Intergovernmental Affairs, Office Of Congressional and Intergovernmental Affairs Certified Mail **7015 0920 0001 0706 5069** September 2015, in accordance with United Tribes Declaration of Rights of Indigenous People by the United Tribes General Assembly, Sixty-first Session, and being bound by the Zodiac Constitution, Great Law of Peace, and Law of the **Al'Maurii Khan** and the establishment of a Tribal Trust Charter and signed and sealed by Tribal Council, acknowledged and delivered to United States Department of Energy, Bureau of Acknowledgement; and the established tribal council provides documentation of history, identity and standing of the **AL' MAURI KHAN NATION** via the following:

- (1) our tribes' DNA and / or Blood lineage proof of descent from Ancient [American] Clovis Man of Montana [12.5 kya], Ancient remains from Ust-Ishm, Siberia [45 kya], et al.;
- (2) 1787-1836 treaty of Peace and Friendship between the United States and the Sultan of Morocco;
- (3) 1835 Camp Holmes Treaty
- (4) 1846 Treaty of Hidalgo [between the United States and Mexico]
- (5) 1963 Geneva Convention, esp. the rights of Diplomats;
- (6) the Racial Integrity Act repealed in 1967;
- (7) NAAIP International Affidavit and Notice of Constructive Fraud and Identity Theft, Unlawful Conversion, Economic Deception and Ethnic Cleansing; misidentification and genocide claims against the United States, Commerce Department file number 150387, sent via Certified Mail Numbers 7012 1010 0001 9134 1317 and 7012 1010 0001 9134 1300 and ancestral birth records validating "Native American" standing.

Satterwhite [alleged from England] and Sarah Peterson [an American Aborigine woman mislabeled as West Indian and property] whose Son James Satterwhite [abt. 1838] with his wife Sarah Satterwhite gave birth to Norman Satterwhite who married Gussie Owens [b. 1905] and gave birth to Owen Satterwhite who married Lillian Satterwhite and gave birth to 9 children including my Mother Lillie Satterwhite [whose lineage is from Texas – See April 1, 1930 U.S. Federal Census Page 7B Waelder, Texas ID: 172 and see also birth records attached to claim in U.S. Commerce Department file number 150387, et al.] who married Willie Floyd Beckworth [my Father whose Lineage is from Georgia – See April 19, 1940 U.S. Federal Census Sheet No. 9B], whose Maternal Grandparents were Lee Butler [b. 1892, Georgia] and Bertha Butler [b. 1896, Georgia] and Paternal Great grandparents were Jim Bickworth [b. abt. 1876] and Cornelia Bickworth, serving as proof beyond any shadow of doubt that Our assertion of tribal rights as self-executing and the protections afforded in Our exercise of said rights, as We come forth, under seal, and in full acceptance of the hereditaments named herein and secured herewith, inclusive of and not limited to Our right of free occupation and movement within this land of Our ancestors, are not infringed upon or prejudiced.

I, Sagamoor – Maku – Chief – of the Al'Maurii Khan Nation, by virtue of the authority conferred upon me by the Tribal Council of the Al'Maurii Khan Nation on March 21, 2015, do hereby approve this revised Tribal Trust Charter of Al'Maurii Khan Nation including, but not limited to acceptance of all processes and files, numbers, records, identifications, persons and lands utilized by the Al'Maurii Khan to legally establish its standing alongside the Tribal Clans / Tribes of the World and are the property of the Al'Maurii Khan Tribal Trust. This Trust Charter is effective from and after such time as it may be ratified by a majority vote of the adult members

*of the Tribe / Clan voting; provided, however, that such election shall be void unless the total vote cast is at least 30 percent of those entitled to vote. **END EXCERPT.***

INTENT

We, the blood descendants of Al'Maurii Khan Tribal Nation as heirs to Treaty² rights, are not asking for recognition through your recognition process, but are seeking acknowledgement by your agency in accordance with the Supreme Court ruling of Loving vs. Virginia and the repeal of the Racial Integrity Act in 1967. We are the bloodline descendants of misidentified American Indians Ernest Owen (Asa) Satterwhite, Lillian Satterwhite, Lee Butler, and Bertha Butler, whose genetics [i.e. bloodline] on this land goes back some 12.5 kya and whose sacred seat of birth place has been claimed under trust as international intellectual property known as land area described above via latitude and longitude in America, and is the exclusive sacred, intellectual and real property of the Al'Maurii Khan Tribal Trust, whose aboriginal indigenous rights are protected as per United States Executive Order 12803 and 49 Statute 3097 Treaty Series 881, also, United Nations Declaration on the Granting of Independence to Colonial Countries and Peoples on 14 December 1960, UN GA/Res 1514(XV) and by provisions of customary and treaty based international law, granting the people all powers that had previously been claimed and exercised by alien peoples and their agents and assigns. Basic requirements that colonizing people transfer all powers to the colonized peoples is mandated at Article 5 of this Declaration and the affirmation of the Declaration on the Rights of Indigenous Peoples by the General Assembly A/61/L/67 September 7, 2007;

United Nations Declaration of Indigenous Rights 2007; including; Article 37, (1)Indigenous peoples have the right to the recognition, observance and enforcement of treaties, agreements and other constructive arrangements concluded with States or their successors and to have States honor and respect such treaties, agreements and other constructive arrangements. (2) Nothing in this Declaration may be interpreted as diminishing or eliminating the rights of indigenous peoples contained in treaties, agreements and other constructive arrangements. No one shall be arbitrarily deprived of his property, per the dictates of the Universal Declaration of Human Rights, Article 17(2),

Also enjoined and enforced through the Non Intercourse Act of 1790, requiring proof of land ownership; where Indian land cannot be sold. This public notice demands any alleged owner to come forward with proof of ownership of claimed lands, lands claimed under international law; the claims of the Al'Maurii Khan tribal trust are superior claim.

This "**Constructive and Public Notice**" is presented by the following appointed Representative to establish this first "Public Notice" based on the abovementioned tribal declarations:

of the Al'Maurii Khan Tribal Nation whose clan families have endured years of fraud and destruction, with forced adherence to provisions of United States' colonizing legacy. The deliberately applied methods and actions by the State of Texas, the State of Georgia, the State of Florida, State of Colorado, et al. in ignoring the rights of the AL'MAURI KHAN clans with deception and complete degradation of rights including the current and continued destruction and barring of AL'MAURI KHAN clans from full spiritual and emotional enjoyment of sacred ancestral sites and land areas and denying a return to self-determination. With the onset of new world governments, land claims and identity concerns, the clans of Al'Maurii Khan Tribal Nation reject the debilitating standards, the continued theft of identity, history, property, the subjugation and annihilation of natural freedoms to regain our culture and people; such acts are forever rejected by the AL'MAURI KHAN clans people from beginning to the present. The names, roll numbers, member DNA / Blood, and other information provided to establish the AL'MAURI KHAN Tribal Trust Charter, lends truth and validation of lawful and legal rights, standing and status of the Al'Maurii Khan Tribal Nation and Sacred Tribal Trust, established via Divine Law, Ecclesiastic Law, and the provisions of American Indian law, Customary International law, United States law and the law of my Ancestors, and the laws of the United States Supreme Court.

Through the Al'Maurii Khan Tribal Trust Charter, all cultural and commercial activities, tribally owned lands, properties, and peoples shall be protected in accordance with Tribal Trust Charter's Orders, Tribal Constitution / Indian Law, Declarations, Constructive Notices, and other lawful constructs, with mutual understanding and harmony with the United States of America, an appendage of the old Moorish Empire of North America – Al'Maghreb Al' Aksa.

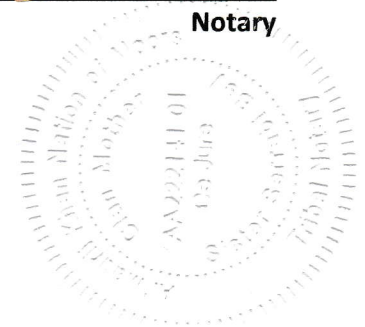
