**RE:** Misrepresented Instruments – Bills of Attainder / Foreign Bills of Exchange in the above styled accounts / case number: 2019MM002200 and, esp. the filings titled DEAR VIOLATOR LETTER/FAILED TO PAY filed on 10-11-2023, AFFIDAVIT OF PROBATION filed on 11-02-2023, and AFFIDAVIT OF PROBATION/NOTICE TO APPEAR filed on 11-02-2023, and the most recent unlawful arrest (Orange County Court Case No. 482025MM405883000AOX) on 07-30-2025 by the ORANGE COUNTY SHERIFFS OFFICE – all of which do not meet the basic required standards to be able to be able to be satisfied with an actual circulating United States currency issued under the Supreme laws of the land and backed by international banking law.

**Stare Decisis Law** 

"A court cannot confer jurisdiction where none existed and cannot make a void proceeding valid. It is clear and well-established law that a void order can be challenged in any court." See Old Wayne Mut. L Assoc. v. McDonough, 204 U.S. 8, 27 S.Ct. 236 (1907)

Merely being impertinent to an officer or daring him to make an arrest has been declared insufficient to amount to interference with him in the performance of his duties. Pinkerton v. Verberg, 78 Mich. 573, 44 N.W. 579, & L.R.A. (N.S.) 199.

In Allen v. State, 183 Wis. 323, 197 N.W. 808, 39 A.L.R. 782, it was held that a search by police officials of a person whom they have illegally arrested without warrant, and without knowledge that he is committing an offense is illegal, and the evidence offered cannot be used against him in support of a prosecution for an alleged offense.

For the record, Bro. Amir R.S. Al-Bey ex-relatione: EDWIN ORLANDO RIVERA, is a Moorish-American, non-citizen national, and this information has been a matter of Florida's Public records of Broward County, Florida, United States of America since at least 2016. He has been received by and is recognized as a Moor and or American aborigine by the Al'Maurii Khan Nation of Moors of North America since 2014 and by the Office of the President of the United States of America since 2016 (see Exhibit A-2 Correspondence from the POTUS), affording him and his person, as well as, any property held under any other derivative an enjoyed sovereign status as a native American Aborigine and or Moor, under Cherifian jurisdiction / (Indian Law) according to the Al'Maurii Khan Nation Tribal Constitution and Codex, the Treaty protections, and the privileges and immunities afforded him as a Moor. He, is a Man of Flesh and Blood, animated by Divine Spirit, he [like all of the Creator's Sentient Beings, i.e. Man and or Woman] is not and cannot be named in the statute under Florida law and is also guaranteed a protected person status under international law (Geneva Convention, U.N. Human Rights Agreements) and federal law (Public Law 94-467: 18 U.S.C. §1116(4)(B)). Please see County records styled the Public Notice: Affidavit of Allodial Permit presented to the Florida Governor and the President of the United States of America and also filed in Broward County, with the Clerk of the Court as Instrument Number 113580351 [28 Pages]. The OSCEOLA County Court and Clerk or Law equivalent and their statutory presumptions and claims of jurisdiction as they relate to him and his person / estate / property do not represent any one of the 5 branches of sovereign authorities described in the Organic Constitution for the United States of America [ergo said constitution for U.S.A. recognizes only the sovereignty of (1) the Legislature / Congress through 2/3rds majority vote (2) the Supreme Court's unanimous decisions (3) the Executive authority of the President (4) the Will of the American people (5) the American Military under the Commander in Chief ].

"We are mindful that rights of succession to property under local law may be affected by an overriding federal policy when a treaty makes different or conflicting arrangements. In such event, the state policy must give way". Clark v. Allen, 331 U.S. 503, 517 . . . . 220 Ore. 448, 462, 349 P.2d 255, 262-263. —In other words, the Black Codes, Liber Code, and other local rules and customs that restricted / prejudiced his or his ancestor's property rights cannot preclude the treaty obligations of the United States and the enforcement of the claim of rights to property, without unlawful intrusion or forced assimilation by the state, the freedom to be identified as whom he says he is, as he has asserted in this matter — but more specifically the right(s) to freedom of

movement and the occupation of ancestral lands, of religious worship, to govern oneself, to not be subjected to involuntary servitude, and to enjoy the basic unalienable rights as guaranteed any free inhabitant of any territory according to the supreme law and the Divine Law.

#### **Jurisdiction and Venue**

Let the records of the administrative court of Osceola County reflect that, Bro. Amir R.S. Al-Bey ex-relatione: Edwin Orlando Rivera, has since at least February 1<sup>st</sup> 2016, invoked his religious freedoms, tribal customs, and tribal rights under the Moorish Zodiac Constitution, which is foundational to the Tribal constitution and code laws of the Al'Maurii Khan Nation to which tribal jurisdiction under the laws of the Al'Maurii Khan Nation of Moors of North America is supported by the perpetually binding 1838 Florida Constitution – Art. I Basic Rights and the [perpetual] consular authority guaranteed under the 1836 U.S.A. – Moorish Empire Treaty of Peace and Friendship, Art. XX; said state, treaty, and tribal laws aver the following:

- **"1836 U.S.A.** Moorish Empire Treaty of Peace and Friendship, Article(s) 20. If any of the Citizens of the United States or any Persons under their Protection, shall have any Disputes with each other, the Consul shall decide between the Parties, & whenever the Consul shall require any aid or Assistance from our Government to enforce his Decisions, it shall be immediately granted to him.
- & 21. If a Citizen of the United States shall kill or wound a Moor, or on the contrary if a Moor shall kill or wound a Citizen of the United States, the Law of the Country shall take place & equal Justice Shall be rendered the Consul assisting at the Tryal; & if any Delinquent shall make his escape, the Consul shall not be answerable for him in any Manner whatever."
- "Al'Maurii Khan Nation Tribal Constitution, Article 8 Section 2. Jurisdiction. The judicial power shall extend to all cases, in law and equity, arising under the Constitution of the Al'Maurii Khan Tribal Nation, the Laws of the Al'Maurii Khan Tribal Nation, Nation Governmental Councils, to all tribal Nationals and property within the jurisdiction of the Al'Maurii Khan Tribal Nation, and Al'Maurii Khan Tribal Trust.
- **Al'Maurii Khan Nation Tribal Codex 404.2(a)** All tribal claims and actions against land and or property shall be under the jurisdiction of the Tribe and administered by the Tribal Court."
- "1838 Florida Constitution Article I Basic Rights. Section 1. That all freemen, when they form a social compact, are equal; and have certain inherent and indefeasible rights, among which are those of enjoying and defending life and liberty; of acquiring, possessing, and protecting property and reputation; and of pursuing their own happiness.
- **Section 2.** That all political power is inherent in the people, and all free governments are founded on their authority, and established for their benefit; and, therefore, they have, at all times, an inalienable and indefeasible right to alter or abolish their form of government, in such manner as they may deem expedient.
- **Section 3.** That all men have a natural and inalienable right to worship Almighty God according to the dictates of their own conscience; and that no preference shall ever be given by law to any religious establishment, or mode of worship in this State.
- **Section 7.** That the people shall be secure in their persons, houses, papers, and possessions from unreasonable seizures and searches; and that no warrant to search any place, or to seize any

person or thing, shall issue without describing the place to be searched, and the person or thing to be seized, as nearly as may be, nor without probable cause, supported by oath or affirmation.

**Section 8**. That no freeman shall be taken, imprisoned, or disseized of his freehold, liberties, or outlawed or exiled, or in any manner destroyed or deprived of his life, liberty, or property, but by the law of the land.

**Section 9.** That all Courts shall be open, and every person, for an injury done him, in his lands, goods, person, or reputation, shall have remedy by due course of law; and right and justice administered without sale, denial, or delay.

**Section 10.** That in all criminal prosecutions, the accused hath a right to be heard by himself or counsel, or both; to demand the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor; and in all prosecutions by indictment or presentment a speedy and public trial, by an impartial jury of the County or District, where the offense was committed; and shall not be compelled to give evidence against himself.

**Section 27**. That to guard against transgressions upon the rights of the people, we declare that every thing in this article is excepted out of the general powers of government, and shall forever remain inviolate; and that all laws contrary thereto, or to the following provisions, shall be void."

### Facts of the Matter

The named defendant in this matter was manufactured by U.S. instrumentalities, is an ens legis entity / 14<sup>th</sup> Amendment person, and is being attached to the actual estate of a Moor that represents tribal trust res under laws of the tribe and Moorish customs; to date there is no information in records of this case permitting any form of constructive trust through the union of a Moor and the ens legis entity named as the defendant in this matter.

The court is attempting to enforce an agreement between the Moor and APRIL STACKS, whom have never had a meeting of the minds to produce any enforceable contract under the laws of the United States of America. In fact, the information presented by APRIL STACKS as an Oath attempts to enforce said agreement as true or valid in order to extinguish previously contracted rights and obligations of the accused and the state under the treaties of the United States of America. The presenting of said documents and other offers for services to compel payment / performance against the charges alleged do constitute forcing improper, unwanted and or unnecessary services upon the business of Moors, which violates Art. 15 of 1836 U.S.A. – Moroccan Empire treaty.

The location where the unlawful arrest and detention were initiated was in a home on lands that belongs to aboriginal people (Moors / Moorish-Americans) as evidenced by *Exhibit A-3: Chapter 47 of the Holy Moorish Koran*, and the U.S.A. – Moorish Empire Treaty / Moorish Land Grant sealed by the Sultan of Morocco (1787) which confirms that said lex situs is within lands that are occupied by U.S. establishments as admitted to by NAICS (North American Industry Classification System), but still rightfully belonging to American aborigines (Moors) and is located within Moorish lands and territory described in the *Legal Deed and Trust* Document filed in the Library of Congress under Certified Registration No. TXU-1-123-633, and Control Number 71-330-6977 (U), The Department of Homeland Security – U.S. Customs and Border Protection – Recordation No. COP 04-00062; Control Number 476030 LMW, and Catalogued in the United

States Department of State, Bureau of Administration – Department of State Library – Call Number BP232 .U73 2004 (sic. Al'Maurii Khan Nation Tribal Constitution Article 1 – Territory).

Probation was completed as of 02-08-2021. He was supervised under Tribal law and governed himself accordingly throughout the time. He does not use alcohol or drugs, and has not had any violations of Tribal, State, local or Federal laws since that unlawful arrest on 06-06-2019. Most recently on 07-30-2025 he was wrongfully accused resisting arrest on Mission Premises of Al'Maurii Khan Nation and illegally detained and arrested for an the alleged warrant, which is well beyond the probation period attached to the alleged violation of probation filed on 04-15-2020 by a merchant soliciting probation services, contrary to what the Moor thinks is proper for his business.

Bro. Amir R.S. Al-Bey ex-relatione: EDWIN ORLANDO RIVERA reserved his right(s) to protect his own health and safety, retreated to an even more restrictive diet and stayed away from the public and others to avoid contracting COVID, as 03-09-2020 is the same day the COVID-19 outbreak began and on that day Honorable: Governor Ron DeSantis issued Executive Order 20-52 declaring a state of emergency for the entire State. The Bond was discharged on 03-10-2020 by the Deputy Clerk. See Exhibit A-4 as evidence that bond was discharged and case was closed and re-opened to strip the constitutionally protected rights of a Moor of the Al'Maurii Khan Nation, without proof of jurisdiction, a valid contract, or any victim of the actions of our Tribal National.

### **Quo Warranto**

GABRIELLE SANDERS-MORENCY, YOU ARE HEREBY COMMANDED to produce the following for the records, that should be in your care, as proof and evidence of your lawful jurisdiction and judicial authorization per Rule 2.420(b)(3):

- 1. Produce a certified copy of your Delegation of Authority order from Congress per Article III section 1 & 2 of the Constitution for the United States of North America as evidence of the private foreign de facto corporate entities named OSCEOLA COUNTY FLORIDA (Inc.), OSCEOLA COUNTY (Inc.), OSCEOLA COUNTY SHERIFFS DEPARTMENT (Inc.), STATE OF FLORIDA (Inc.), and FLORIDA DEPARTMENT OF CORRECTIONS (Inc.), or any representative thereof having been lawfully conferred judicial authorization and jurisdiction to hear and decide cases between a Moor (sic. Tribal Nationals of the Al'Maurii Khan Nation of Moors of North America) and the 14<sup>th</sup> Amendment / legislative citizens of the United States;
- 2. Produce your copy of the alleged valid and verifiable contract or commercial agreement which obliges the Moor and their private person (decedent, estate, vessel, or flesh and blood body) to any commercial (trafficking) statute, code, rule, or regulation of the private foreign de facto corporate entities named OSCEOLA COUNTY FLORIDA (Inc.), OSCEOLA COUNTY (Inc.), OSCEOLA COUNTY SHERIFFS DEPARTMENT (Inc.), STATE OF FLORIDA (Inc.), and FLORIDA DEPARTMENT OF CORRECTIONS (Inc.);
- 3. Produce the certified copy of an alleged written accusation signed under penalty of perjury by an identifiable natural person claiming to have a valid agreement for performance or to be the plaintiff / injured party (corpus delicti) and NOT a witness to the claims in Account / Case Number(s): 2019MM002200 in support of the allegations against, Bro. Amir R.S.

- Al-Bey ex-relatione: EDWIN ORLANDO RIVERA lawful, in order to satisfy the requirement of "standing" pursuant to stare decisis law in Allen v. Wright, 468 U.S. 737, 751 (1984) ("The requirement of standing, however, has a core component derived directly from the Constitution. A plaintiff must allege personal injury fairly traceable to the defendant's allegedly unlawful conduct and likely to be redressed by the requested relief.");
- 4. Produce the name, address and telephone number of the public hazard and or malpractice bonding company, the policy number of the bond, and if required, a copy of the policy describing the bonding coverage of the specific job performance of you (plural) and all other natural persons acting as employees / contractors / agents / representatives of the OSCEOLA COUNTY FLORIDA (Inc.), OSCEOLA COUNTY (Inc.), OSCEOLA COUNTY SHERIFFS DEPARTMENT (Inc.), STATE OF FLORIDA (Inc.), and FLORIDA DEPARTMENT OF CORRECTIONS (Inc.) being associated with U.S. DOMESTIC ACCOUNTS / CASE NUMBERS: 2019MM002200, and inclusive of the Misrepresented Instruments Bills of Attainder / Foreign Bills of Exchange mentioned above;
- 5. Proof from the County Tax Collector or any fellow custodian, obligated to the disclosure requirements under Rule 2.420(b)(3), in the form of a sworn statement, that this one (1) open account / case is not a taxable event that must be reported to the Internal Revenue Service;
- **6.** Proof from the County Tax Collector or any fellow custodian, obligated to the disclosure requirements under Rule 2.420(b)(3), in the form of a sworn statement, that the estate [/ person] of EDWIN ORLANDO RIVERA is NOT or has not been claimed as tribal property subject to the jurisdiction of the Al'Maurii Khan Nation since at least 2014.
- 7. Proof that Bro. Amir R.S. Al-Bey ex-relatione: EDWIN ORLANDO RIVERA has NOT consented to the exclusive exercise of criminal, civil, and ecclesiastic jurisdiction of the Moroccan Empire, administered through the Al'Maurii Khan Nation, a Moorish Tribal Government in North America, notwithstanding to protect any actions repugnant to the laws of the United States of America.

### **Days of Grace to Answer**

You have 20 days from your receipt of this affidavit of fact: Writ of Quo Warranto to answer and produce the above evidence for the record in accordance with international law and local laws supporting full disclosure of certain public records by the custodian of said records.

THE PROCEEDINGS IN Case Number: 2019MM002200 ARE NOT VALID AND CANNOT PROCEED until jurisdiction is proved to exist! Otherwise, the misrepresented instrument – bills of attainder / foreign bills of exchange / Case Number: 2019MM002200 and any other attachments associated thereto must be dismissed with prejudice for lack of [territorial and personal] jurisdiction and fraud. See Melo v. United States, 505 F.2d 1026 ("Once jurisdiction is challenged, the court cannot proceed when it clearly appears that the court lacks jurisdiction, the court has no authority to reach merits, but, rather, should dismiss the action.").

Failure to answer and produce the above evidence constitutes DEFAULT and serves as your admission by silence to lack of jurisdiction and fraud; and the misrepresented instrument – bills of

attainder / foreign bills of exchange / Case Number: 2019MM002200 and any other attachments associated thereto being invalid, unconstitutional, notwithstanding, void ab initio, and unenforceable. See Elliot v. Peirsol, 26 U.S. 328, 340 (1828) ("If a court acts without authority, its judgements and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgements, or sentences, are considered, in law as trespassers."); also, see United States v. Throckmorton, 98 U.S. 61 ("Fraud vitiates the most solemn contracts, documents and even judgements."). ## Holy Moorish Koran Chapter XLVII

## Egypt, the Capital Empire of the Dominion of Africa

- 1. The inhabitants of Africa are the descendants of the ancient Canaanites from the land of Canaan.
- 2. Old man Cush and his family are the first inhabitants of Africa who came from the land of Canaan.
- 3. His father Ham and his family were second. Then came the word Ethiopia, which means the demarcation line of the dominion of Amexem, the first true and divine name of Africa. The dividing of the land between the father and the son.
- 4. The dominion of Cush, North-East and South-East Africa and North-West and South-West was his father's dominion of Africa.
- 5. In later years many of their bretheren from Asia and the Holy Lands joined them.
- 6. The Moabites from the land of Moab who received permission from the Pharaohs of Egypt to settle and inhabit North-West Africa; they were the founders and are the true possessors of the present Moroccan Empire. - 8. The River Nile was dredged and made by the ancient Pharaohs of Egypt, in order to trade with the surrounding kingdoms. Also the Niger river was dredged by the great Pharaoh of Egypt in those ancient days for trade, and it extends eastward from the River Nile, westward across the great Atlantic. It was used for trade and transportation.
- 9. According to all true and divine records of the human race there is no negro, black, or colored race attached to the human family, because all the inhabitants of Africa were and are of the human race, descendants of the ancient Canaanite nation from the holy land of Canaan.
- 10. What your ancient forefathers were, you are today without doubt or contradiction.
- 11. There is no one who is able to change man from the descendant nature of his forefathers; unless his power extends beyond the great universal Creator Allah Himself.
- 12. These holy and divine laws are from the Prophet, Noble Drew Ali, the founder of the uniting of the Moorish Science Temple of America.
- 13. These laws are to be strictly preserved by the members of all the Temples, of the Moorish Science Temple of America. That they will learn to open their meeting and guide it according to the principles of Love, Truth, Peace, Freedom and Justice.
- 14.
