

#### ABSTRACT:

#### **BRIDGE BUILDING & WING CONTEST**

We are now in the final stage of the eleventh annual light weight composite bridge building contest, to be conducted on the floor of the SAMPE 2008 exhibition. Since the contest started, we have had more than 440 teams entering and more than 700 participants, most of them college students. There is a full writeup of last years contests in the September 2007 issue of the Journal. Rules for the 2008 contests SAMPE are posted on the website. www.SAMPE.org

Both contests start with kits of composite materials being sent to the entrants. Bridges and wings are designed and built at home or company/school shop, and then brought to the Exhibition for testing. The small entrance fee is charged to defray some of the costs and also to ensure the commitment of the entrants. Bridge teams are made up of university students. Wing teams are usually university students, but we allow professional SAMPE members to compete as well.

What we need from you is help in getting some worthwhile composite related prizes or raw material donations that we can package into the kits. Last year's kits contained epoxy resin, adhesives, carbon and glass fabrics and tapes, braids, small spools of fibers, and various core materials. All the materials are in some way related to FRP fabrication. Our target is to have at least 75 team entries this year, so bear in mind that if you volunteer some material, we need 75 of them to keep the contest equal.

Please read the rules to get an idea of the types of products that could be useful in the kit. If you can't be a material supplier, we still need the prizes. We will also take small cash contributions and last year we gave out about \$5000 in prize money, which was left over after all expenses were paid. Checks can be made payable to the New Jersey SAMPE Chapter and mailed to Howard Kliger (Howard's address is on page 6).
