- ★ **Did you recently complete an FEA membership application?** If so, and to ensure you are added to the FEA-SR email distribution list and granted website access as soon as possible, please use your phone or device to scan the QR code below. This will prompt you to provide your name, the installation you work on, and your personal/non-DoDEA email address. **Note:** If you decide not to scan the QR code, please be aware that it could take several weeks for FEA Washington to process your membership application and send your information to us (FEA-SR). We recommend scanning the QR code below to speed up the process!
