\*I authorize the Federal Education Association (FEA) or its designated local, as indicated by my Payment Method selection above, to initiate or continue per my previous authorization payroll deductions, EFT or Credit Card payments for annual membership dues, fees and assessments required for membership in the associations. I further authorize those payments to be made through the initial membership year ending August 31, 2024, and on a recurring basis thereafter, payable in bi-weekly installments on the schedule set by my FEA Area (currently, 15 installments for Stateside [including Guam] and 10 installments for Pacific and Europe [including Cuba]), or in Full, as indicated by my Payment Method selection, above. I understand that the final installment amount for the membership year will include any residual amount owed. The residual amount represents the portion of the combined total that cannot be evenly distributed among the installments.

I understand that in the event one or more of the governing bodies of NEA or its affiliates authorizes a change in the amount of annual dues, fees and/or assessment, FEA or my local will notify me not less than (10) days in advance of processing any changes to the transaction amount charged or debited to me or collected via payroll deduction. Following that notice, I authorize the FEA or local to adjust the amount to be charged to or debited from my account or collected from me via payroll deductions to satisfy any modification by adjusting my payments equally over the payment schedule.

I understand that this authorization for the payment of membership dues, fees and assessments continues year-to-year and shall remain in effect until the earlier of: 1) the termination of my eligibility to maintain membership in the Association; or 2) my written notice to terminate this authorization, which must be sent via mail to my local Association and include my name, address and membership number. I understand that the rejection of any electronic funds transaction shall not constitute the termination of my membership in the NEA. I further understand that FEA or the local will notify me in writing or via e-mail if a transaction is rejected and I shall have seven (7) calendar days to provide updated account information or an accepted alternative method of payment, to continue my payments for annual dues, fees, and assessments.
