## SOUTHLAND INDEPENDENT SCHOOL DISTRICT ORDER OF SPECIAL ELECTION FOR TAX RATIFICATION ELECTION

On this the 21st day of August 2017, the Board of Trustees of the SOUTHLAND INDEPENDENT SCHOOL DISTRICT convened with sufficient members present to constitute a quorum, and among other proceedings had by said Board of Trustees were the following:

WHEREAS, if a school board adopts a tax rate above its Maintenance and Operations rollback tax rate, it must hold an election to ratify that rate; and

WHEREAS, the proposed 2017 tax levy upon all the real property situated within the limits of the Southland Independent School District and all personal property which was owned within said district on the first day of January 2017, except so much thereof as may be exempt by the Constitution and laws of the State of Texas, a Maintenance and Operation tax of and at the rate of \$1.17 Dollars on each One Hundred and No/100 (\$100.00) Dollars of assessed valuation of said taxable property will be levied for the year 2017 for general school purposes and to pay the current operating expenses of said School District for the 2017-2018 fiscal year which tax, when collected, shall be appropriated to and deposited in and to the credit of the Maintenance and Operating Fund of said school district; and

WHEREAS, the Board's adoption at its August 21, 2017, Board meeting of the combined Maintenance and Operations tax rate results in the need for a tax rate ratification election to be conducted under the provisions of Texas Tax Code § 26.08, for Tuesday, November 7, 2017, a date in excess of thirty (30) days from the adoption of the tax rate and less than ninety (90) days from that date; and

WHEREAS, adopting the \$1.17 Maintenance & Operations tax rate would raise more taxes for Maintenance and Operations than last year's maintenance and operations tax rate; and

WHEREAS, it is necessary for this Board to adopt this Election Order establishing the procedure for conducting said Tax Ratification Election:

Therefore, it is hereby ORDERED by the Board of Trustees of the Southland Independent School District that a Special Election to Ratify School Taxes be called as follows:

An election is hereby ordered to be held on Tuesday, November 7, 2017, for the purpose of the voter approval of the Board's adoption of a Maintenance and Operations tax rate of \$1.17 per \$100.00. Specifically, the following proposition will be on the ballot:
