

# **Terms & Conditions**

In these Terms & Conditions, the following terms are employed with the meanings set out below:

## Definitions

- **Account:** The Member's dedicated personal area within the Application, which they access upon registration and login. It enables the Member to access the Services. A Member may only have one Account.
- **Application:** The MeetNC application, available on the Apple App Store and Google Play Store.
- **MeetNC:** The name of the application.
- **MeetNC (meet)** An meeting created between two profiles, triggered by a let meet invite on both profiles., Allowing Members to start a conversation.
- **Female Members:** Members registered on the Application as female.
- **MeetNC subscription** will initially be free. When enough subscribers have joined, a charge of five dollars per week will incur. Subscribers will be notified when this happens. They then will have the option to unsubscribe or continue with paid subscription.
- **Male Members:** Members registered on the Application as male.
- **Member:** A person registered with the Application.
- **Services:** All services, whether charged or free, offered by MeetNC to encourage virtual or real-life meet-ups between Members who are in the same location and who have mutual interest in each other, according to selected search criteria.
- **TOC:** These Terms & Conditions.

---

## Article 1: Scope

The TOC defines the rights and obligations of the parties when using the Application. They form the basis of the contractual relationship between the Member and MeetNC.

### 1.1 Conflicting Rules

These TOC determine the main rules of use for the Application. They are supplemented by additional policies – the Privacy Policy – to provide the Member with clearer guidance on how to use the Application. In the event of a conflict between the various policies making the rules

inaccessible, unintelligible, and/or unpredictable, these TOC shall prevail over the Privacy Policy and the Confidence Charter.

## 1.2 Independence of Provisions

Should any provision of these TOC be declared invalid or inapplicable due to legal, regulatory, or judicial rulings, the other provisions shall remain effective and in force unless these TOC become distorted or significantly unbalanced.

## Article 2: Amendments to the TOC

### 2.1 Updates

MeetNC reserves the right, unilaterally and at any time, to add to or amend these TOC or terminate the Services. The Member will be informed of updates via the Application and/or email. It is the Member's responsibility to ensure that their email address is valid.

### 2.2 Immediate Effect

All new versions of the TOC shall be effective immediately for all Members.

---

## Article 3: Governing Law and Dispute Resolution

### 3.1 Governing Law

These TOC shall be governed by law, exclusive of its conflict of laws rules.

### 3.2 Dispute Resolution

In the case of a dispute, the Member agrees to contact MeetNC in writing (via email or letter) before taking legal action to seek an amicable resolution. If this fails, the Member may seek mediation free of charge. Unresolved disputes will be submitted to the relevant courts in Newcastle NSW

## Article 4: Registration

### 4.1 Application Download Options

The Application is available for free download from the Apple App Store and Google Play Store for iPhones (iOS 11 or higher) and Android Smartphones (version 5 or higher).

## 4.2 Member's Rights Upon Registration

Upon meeting the conditions for Member status, MeetNC assigns a personal Account, including:

- A profile page
- An inbox
- A "notifications" option

## 4.3 Member's Obligations Upon Registration

- The Member must be at least 18 years old.
- The Member guarantees that all registration information is accurate and up to date.
- Registration can be done via the APP store

---

## Article 5: Services and Features

### 5.1 Purpose of the Service

The Application provides Members with a platform to connect with others nearby for virtual or real-life meetings. MeetNC is not a counseling or matchmaking service but facilitates connections between individuals with shared interests.

### 5.2 Free Services for Members

- Messaging with a MeetNC (event)
  - Viewing other Members' profiles
  - Passing an unlimited number of profiles
  - Blocking inappropriate Members
  - Receiving notifications
  - Consulting the FAQ and Tutorials

## Article 6: Protection of Personal Data

MeetNC is committed to privacy and data protection. Please read our Privacy Policy and Confidence Charter for details.

---

## Article 7: MeetNC's Obligations and Liability

### 7.1 Technical Resources and Security

MeetNC provides the necessary infrastructure for a high-quality service but is not responsible for:

- Device compatibility issues
- Internet provider failures
- External factors affecting service availability

### 7.2 Illegal Conduct

MeetNC is not liable for illegal activities by Members, including but not limited to:

- Scams
- Commercial use
- Prostitution
- Identity theft
- Intellectual property violations

### 7.3 Reporting and Moderation

Members can report abusive or unlawful behavior. Verified violations may result in account suspension or termination.

### 7.4 Duty of Caution

Members are solely responsible for verifying the identity of individuals they meet in real life. MeetNC is not liable for any issues arising from such meetings.

## 7.5 Group Events

MeetNC prohibits using the Application to organize group demonstrations or events.

## Article 8: Member Code of Conduct

### 8.1 Registration Honesty

To maintain integrity, Members must:

- Be at least 18 years old
- Provide truthful information
- Keep profile details up to date
- Have only one account

MeetNC reserves the right to investigate suspicious accounts and may request identity verification. If a violation is confirmed, the account may be suspended or terminated.

### 8.2 Duty of Fairness and Honesty during Use

To remain a Member, all of the following conditions must be met:

- Be honest and truthful in their statement
- Refrain from posting any confidential information about others, such as financial data.
- Avoid posting any content or photos on the Application that are pornographic or violate modesty and human dignity.
- Respect the private nature of content and conversations exchanged with other Members through the Application and refrain from disclosing the content of such messages to third parties.
- Refrain from violating intellectual property rights or laws governing personality rights.
- Refrain from disrupting public order.
- Avoid defamation and the use of insulting language, particularly language that is racial or discriminatory.
- Comply with all applicable laws and regulations.

- Refrain from inciting violence or promoting terrorism, war crimes, or crimes against humanity.
- Follow proper etiquette and maintain politeness when interacting with other Members.
- Avoid interfering with the normal operation of the Application's Services or infrastructure in any manner.
- Do not use bots or tools other than those provided by MeetNC to contact other Members.
- Do not use the Application to arrange professional services, such as escort services or similar activities.
- Refrain from approaching Members for the purpose of promoting paid services or products.
- Do not share login information, including usernames and passwords, with other Members.
- Do not use the Application to organize gatherings or demonstrations.
- Members must not copy, disseminate, or transfer technical data intercepted from the network connected to the MeetNC application.

### 8.3 Personal Use

Members agree to use the Application strictly for personal purposes. The MeetNC network must not be used for commercial, promotional, electoral, or recruitment purposes. It is strictly prohibited to send marketing messages, commercial content, or newsletters through the MeetNC inbox, including but not limited to links to third-party sites, competitor content, or other promotional materials.

### 8.4 Member's Liability

Each Member is solely responsible for their actions and the data they publish through the Application.

If MeetNC is held liable due to a Member's failure to comply with these Terms, the Member must indemnify MeetNC against any legal consequences, claims, or damages resulting from such infringement.

Members may report unlawful content that violates the law or these Terms using the moderation tools provided by the Application, in accordance with Article 7.3.

## 8.5 Photos

Uploading photos of a pornographic or exhibitionist nature, or that otherwise violate modesty and moral values, is strictly prohibited. Posting such photos constitutes a serious violation and may result in account suspension and/or termination, along with potential legal consequences.

## 8.6 Real-Life Meet-Ups

MeetNC encourages Members to exercise caution when arranging in-person meet-ups. Members are solely responsible for verifying the identity of those they meet. These meet-ups occur independently of MeetNC, and MeetNC assumes no responsibility for any issues arising from such meetings.

For safety reasons, Members are advised not to share personal information, such as phone numbers, addresses, or surnames, too quickly. Meetings should take place in public locations, and it is recommended that a friend or family member be informed of the meeting details.

## 8.7 Account Management

Members should regularly check their inbox and notifications, as MeetNC will use these channels to share important updates regarding its Services. These updates may also be sent to the email address linked to a Member's registration.

Each Member is responsible for maintaining the confidentiality of their login credentials. MeetNC is not liable for any misuse of an account due to unauthorized access.

## 8.8 Equipment

The Member is solely responsible for obtaining and maintaining the necessary equipment (hardware, software, internet access, etc.) to use the Services. MeetNC does not bear any costs related to telecommunications or device maintenance.

## Article 9 Payment Term

### Free to payment 9.1 .

MeetNc will be free to begin with. When there is enough subscribers, subscribers will be notified of a five dollars per week charge will commence, giving the opportunity to unsubscribe or continue.

- Payment for the full subscription period of 1 month is required at the time of purchase. A charge once a month will ensue until the subscriber unsubscribes.
- Payments are processed through the Apple App Store or Google Play Store, depending on the device.

- MeetNC does not handle payment processing, exchange rates, or transaction fees.
- MeetNC does not collect or store banking information—this data is managed by Apple or Google.

## 9.2 Early Termination of the Contract

- If a Member violates these Terms or applicable laws, MeetNC reserves the right to terminate their account immediately, without justification.
- No refunds will be issued to MeetNC Prime subscribers upon termination.

---

## Article 10: Communication with Members

### 10.1 Push Notifications

Members may receive push notifications about:

- Lets meet received from other Members.
- Events occurring within MeetNC.
- Messages received from other Members.
- Important messages from MeetNC regarding account activity or services.

Notification settings can be managed within the account settings.

---

## Article 11: Intellectual Property and Fair Competition

- It is strictly prohibited to replicate or create a derivative product based on the MeetNC Application.
  - Any attempt to sublicense, resell, or commercially exploit the Application's services without authorization may result in legal action.

## Article 12: Termination

### 12.1 Uninstalling the Application

- Uninstalling the Application will make a Member's profile invisible but does not immediately delete the account.
- If the account is reactivated within one year, previous data will be restored.

### 12.2 Account Deletion

- Members can permanently delete their accounts via the Application settings or by contacting MeetNC.
- Deleted accounts cannot be reactivated.

### 12.3 Suspension/Termination for Breach of Terms

- MeetNC may suspend or terminate an account at any time if a Member violates these Terms.
- A Member has 30 days to respond to a suspension notice before termination is finalized.

### 12.4 Termination of Inactive Accounts

- Accounts inactive for one year may be deleted after an 8-day notice period.
- Prime Members' accounts are not subject to automatic deletion.

## Article 13: Confidentiality Clause

Neither MeetNC nor the Member may disclose information about their agreement. In case of disputes, both parties agree to resolve matters through confidential negotiations.
