

## **Safari Unlimited Waiver and Release of Liability**

I desire to participate in an endeavor conducted by Safari Unlimited. I understand that this activity may include camping, hunting, fishing, handling and shooting firearms, handling---skinning and processing game animals or fish using knives, saws, and other instruments, also riding in or operating a boat or vehicle. (All of the activities that relate in any way to Safari Unlimited, including those identified above, are referred to as the hunting, fishing, and related activities.)

1. I acknowledge and fully understand that hunting, fishing, and related activities involve the risk of serious injury, including permanent disability and even death.
2. I acknowledge and fully understand that these injuries, harms and damages may result not only from my own actions, inactions or negligence or the actions of other participants in the hunting or fishing trip, but they are also part of the inherent dangers associated with hunting, fishing, and related activities.
3. I further acknowledge and understand that these injuries, harms, and damages may be caused by the actions, inactions or negligence of Safari Unlimited, their employees, or agents and that such actions, inactions, or negligence may include, but not limited to, the assessment of my experience or ability in connection with hunting, fishing, or related activities, supervision of me while participating in those activities, the care and handling of firearms and other hunting and fishing equipment and instruction on hunting, fishing, and related activities.
4. I understand and voluntarily assume all of the foregoing risks and accept personal responsibility for any damages following any such injury, permanent disability or death.
5. I understand that if I either accidentally or purposely shoot a sporting dog causing injury or death, I am liable up to \$5,000 for medical care and/or replacement of said dog.
6. I understand that I am responsible to know and follow the local laws and limits for hunting and assume responsibility if I go over on a limit, not the guides or Safari Unlimited.
7. I release, waive, discharge, and covenant not to sue Safari Unlimited and/or any of their owners, principals, officers, employees, agents, successors or assigns from any and all liability, losses, damages or costs of any kind or any nature that are caused by or related in any way to the hunting, fishing, and related activities.
8. I ACKNOWLEDGE AND FULLY UNDERSTAND AND AGREE THAT I AM PROVIDING SAFARI UNLIMITED WITH A RELEASE WAIVER AND COVENANT NOT TO SUE. REGARDLESS OF THE ACTUAL, POTENTIAL, OR ALLEGED CAUSE OF ANY INJURIES AND WHETHER OR NOT THOSE INJURIES WERE CAUSED POTENTIALLY CAUSES OR ALLEGED TO BE CAUSED BY:  
(A) MY OWN ACTIONS OR INACTIONS: (B) THE ACTIONS OF ANYONE WHO MIGHT BE PARTICIPATING IN OR RELATED TO THE HUNTING, FISHING, AND RELATED ACTIVITIES, INCLUDING OTHER GUESTS: OR © THE ACTIONS, INACTIONS OR NEGLIGENCE OF ANY KIND WHATSOEVER OF ANY EMPLOYEE OR AGENT OF SAFARI UNLIMITED.

**I HAVE READ THE ABOVE WAIVER AND RELEASE, FULLY UNDERSTAND ALL OF ITS PROVISIONS AND SIGN IT VOLUNTARILY. I FURTHER UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL RIGHTS BY SIGNING THIS WAIVER AND RELEASE.**
