- 2. Indemnity to Landlord. THE UNDERSIGNED TENANT AND HUNTER WILL INDEMNIFY, DEFEND, AND HOLD LANDLORD AND ITS AGENTS, EMPLOYEES, INVITEES, LICENSEES, OR VISITORS (COLLECTIVELY, "LANDLORD") HARMLESS AGAINST ALL CLAIMS, DAMAGES, AND COSTS (COLLECTIVELY, "CLAIMS") INCURRED BY OR ALLEGED AGAINST LANDLORD AND ARISING OUT OF OR RELATING TO ANY ACT OR OMISSION OF THE UNDERSIGNED OR ANY OF THE UNDERSIGNED'S AGENTS, EMPLOYEES, CONTRACTORS, LICENSEES, OR VISITORS (COLLECTIVELY, "HUNTER") WHILE AT THE PREMISES, INCLUDING ANY CLAIMS BASED ON ANY (a) INJURY TO OR DEATH OF ANY PERSON(S), (b) DAMAGE TO OR LOSS OF PROPERTY, OR (c) FAILURE OF HUNTER TO COMPLY WITH ANY APPLICABLE LAWS OR THE LEASE.
- 3. Indemnity to Tennant. THE UNDERSIGNED HUNTER WILL INDEMNIFY, DEFEND, AND HOLD TENANT AND ITS AGENTS, EMPLOYEES, INVITEES, LICENSEES, OR VISITORS (COLLECTIVELY, "TENANT") HARMLESS AGAINST ALL CLAIMS, DAMAGES, AND COSTS (COLLECTIVELY, "CLAIMS") INCURRED BY OR ALLEGED AGAINST TENANT AND ARISING OUT OF OR RELATING TO ANY ACT OR OMISSION OF THE UNDERSIGNED OR ANY OF THE UNDERSIGNED'S AGENTS, EMPLOYEES, CONTRACTORS, LICENSEES, OR VISITORS (COLLECTIVELY, "HUNTER") WHILE AT THE PREMISES, INCLUDING ANY CLAIMS BASED ON ANY (a) INJURY TO OR DEATH OF ANY PERSON(S), (b) DAMAGE TO OR LOSS OF PROPERTY, OR (c) FAILURE OF HUNTER TO COMPLY WITH ANY APPLICABLE LAWS OR THE LEASE.

- 4. Release to Landlord. THE UNDERSIGNED TENANT AND HUNTER WAIVE ALL CLAIMS AGAINST LANDLORD AND RELEASES LANDLORD FROM ANY LIABILITY, BASED ON ANY (A) INJURY TO OR DEATH OF HUNTER OR (B) DAMAGE TO OR LOSS OF ANY PROPERTY BELONGING TO HUNTER.
- 5. Release to Tennant. THE UNDERSIGNED HUNTER WAIVES ALL CLAIMS AGAINST TENANT AND RELEASES TENANT FROM ANY LIABILITY, BASED ON ANY (A) INJURY TO OR DEATH OF HUNTER OR (B) DAMAGE TO OR LOSS OF ANY PROPERTY BELONGING TO HUNTER.
- 6. Negligence of Landlord. THE FOREGOING INDEMNITIES, WAIVERS, AND RELEASES WILL APPLY EVEN IF THE INCIDENT GIVING RISE TO THE CLAIM IS CAUSED IN WHOLE OR IN PART BY THE CONDITION OF THE PREMISES OR BY THE SOLE OR CONCURRENT ORDINARY NEGLIGENCE OF LANDLORD (BUT NOT THE GROSS NEGLIGENCE OR WILLFUL MISCONDUCT OF LANDLORD).
- 7. Negligence of Tennant. THE FOREGOING INDEMNITIES, WAIVERS, AND RELEASES WILL APPLY EVEN IF THE INCIDENT GIVING RISE TO THE CLAIM IS CAUSED IN WHOLE OR IN PART BY THE CONDITION OF THE PREMISES OR BY THE SOLE OR CONCURRENT ORDINARY NEGLIGENCE OF TENANT (BUT NOT THE GROSS NEGLIGENCE OR WILLFUL MISCONDUCT OF TENANT).

- 1. THE HUNTER/ANGLER AGREES TO FOLLOW ALL STATE AND FEDERAL HUNTING AND OR FISHING LAWS, AND AN RULES PERTAINING THE THE PROPERTY OR AREA THEY HUNT OR FISH.
- 2. THE PROPERTY LOCATION WILL BE PROVIDED TO CLIENT VIA EMAIL AND WITH TIMES AND LOCATION ON WHERE TO MEET.
- 3. HUNTING RULES ON PROPERTY AND RULES FROM THE OUTFITTER AND OR GUIDE SHALL BE STRICTLY FOLLOWED, ANY DEVIATION CAN AND WILL RESULT IN FINANCIAL PENALTIES AND OR FULL LOSS AND COST OF ENTIRE HUNT OR FISHING TRIP, THAT THE CLIENT WILL BE RESPONSIBLE FOR.
- 4. TXHCON WILL BE ON SITE TO PROVIDE ANY ASSISTANCE AND OR HELP DURING ANY TYPE OF EMERGENCY, AND CLIENT WILL INDEMNIFY TXHCON LLC AND ITS AGENTS FOR ANY TYPE OF LEGAL RECOURSE.
- 5. PAYMENT METHODS: TXHCON LLC ONLY TAKES CASH, PERSONAL CHECK, CASHIERS CHECK AND CREDIT AND OR DEBIT CARD WITH 3.5% SERVICE FEE ADDED ON. VENMO CAN BE USED TO PAY ANY TYPE OF DEPOSIT.
