### Jonathan Crum - Formal Protest

Jonathan Crum. I am entering a protest into the official minutes in accordance with Ordinance §1-211.

Now comes councilman, Jonathan Crum, pursuant to Ordinance §1-211, and endorses a formal protest to be included in the adopted minutes:

Allowing the *Mayor* in her sole discretion to employ an additional police officer without a majority vote violates merit-based hiring practices and is unethical. Also, a majority vote of Council is first required to employ public personnel, and determine officers per Ordinances \$2-103 and \$2-401. Employing personnel not approved by Council is a misappropriation of Tax Funds. This hiring is bias and lacks transparency and fairness as the position was not publicly posted as required by W.V. anti-discrimination and equal opportunity laws.
