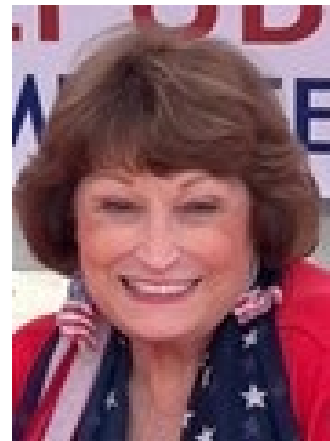

City of Tustin History

Edward R. Bristow
Second Lieutenant
United States Army 359th Infantry 90th Division Company G
Born 20 July 1917
Killed in Action 14 June 1944
Normandy, France

Edward R. Bristow was born on 20 July 1917 in Stroud, Oklahoma, the oldest of five sons to Thomas Pleasant Bristow and Marie Drexel Green Bristow. The family moved to Tustin when Edward and his brother Gilbert were small children. Brothers Harold, Willard and Dean were all born when they arrived in Orange County. Mr. Bristow was a foreman at the Francis Citrus Company for more than 30 years. The family was very involved with the Tustin Advent Church.

Edward Bristow was quite the star in Tustin High's Class of 1936. He was President of the Letterman's Club, Student Body Treasurer, and Treasurer of the Senior Class, ran track, was one of the league's best baseball pitchers and caught the game winning pass in the Thanksgiving Day football game against Escondido. His peers wrote in his senior yearbook that "he was a jolly good fellow".

After graduating from Tustin High, Edward was a bookkeeper while attending college. He enlisted into the Army on 31 October 1942 and completed his basic training in Fort Benning, Georgia before being sent overseas on March 23, 1944. As a member of the 359th Infantry, 90th Division, he participated in the invasion of France and six days after D-Day was wounded and died the same day. He was 27 years old.

The Tustin News wrote an article on his extraordinary family in 1954, saying the most important people in the lives of Thomas and Marie Bristol were their sons. Marie was President of the Gold Star Mothers, and son Harold and his wife were both Air Force Officers. The youngest son Dean would enter the Air Force Academy after Tustin High, but sadly Marie would never see him graduate. She was killed in a traffic accident with her sister-in-law in September 1958.

The Oakes Blaine Newcom House 14841 Yorba Street, Tustin

When O.B. Newcom moved into his Tustin home in 1924, it was one of the finest homes in Tustin. The eleven room, Colonial Revival style home was one of many homes built by E.W. Smith and landscaped by E.U. Fowler. The home took three years to build at a cost of \$15,000 (when the average yearly salary was \$2,100).

O.B. and his brother Richard started the Newcom Brothers Flour and Seed store in their hometown of Dennison, Iowa. After they sold

their business, the brothers moved to Santa Ana, California and started the Newcom Brothers Flour, Feed and Seed Business. They ran a successful business for 5 years until O.B. sold his shares of the business to brother Richard to grow his Valencia Orange ranch fulltime. The brothers also owned “the Big N Farm” in Mason City, Iowa for more than 30 years.

O.B and his wife Daisy moved into their new home with O. B’s two daughters from his first marriage, Lucille and Mary, and O.B’s and Daisy’s two sons, Oakes and John. The boys attended Tustin Union High School.

Landscaping their new home was important for Mr. Newcom. Landscape architect E.U. Fowler built a 50- foot circle in front of the home, lining it with Ligustrum shrubs, planted Irish cypress trees, Chinese cypress trees on the four corners of the home, colorful flowers and installed a “modern” sprinkler system.

O.B. passed away in 1965 and in 1969, his widow sold the home to real estate developer George Agyros. Daisy moved to Santa Ana with her son until her passing in 1980.

The beautiful home still stands today but has had a large two-story structure built onto the back and is now a business complex, with Attorneys, Financial Investment Advisors, and other business tenants.


