CITY OF TUSTIN'S HOUSING ELEMENT REZONE PROJECT –

UPDATE DEC 2024

The Tustin City Council will meet on December 17, at 7 pm, regarding the Rezone Project which includes Enderle Center, Tustin Market Place and Tustin Legacy.

At the last Council meeting in November, out-going Councilwoman Becky Gomez deferred any decision on this project--with agreement by out-going Councilwoman Letitia Clark--until the two newly-elected (and subsequently installed on December 3rd) Councilmen John Nielsen and Lee Fink officially take those vacant seats, which they now have done.

What To Do If Injured:

1. Take many cell phone photos at the scene and exchange necessary contact information with the other side. ~~Never~~ communicate with them again. DO NOT ever communicate with THEIR insurance company representatives! They will mislead you and compromise your case;
2. See a walk-in medical provider within 72 hours to get care and report your injuries and symptoms;
3. Sign-up with a FREE Injury Lawyer immediately to speak for you and guide you. If you do not win you do not pay for anything;
4. Do not discuss your case with strangers / Act to prevent all Social Media posting about your accident and injury by anyone you know.
