**Program Report**



Last month as I was heading to Palm Desert for the weekend I pulled into a McDonalds for a restroom break. As I entered the door, I ran into a female employee coming out of a restroom, noting that the door had a lock I asked if she could unlock it for me. She looked me over and then stated as she unlocked the door that it was for paying customers. Well, that's just good manners I thought, I was planning to get some fries anyway.

As I entered the dining area, it appeared to be in total chaos, people milling about, yelling, no-one at the small counter, only kiosks. I had to purchase French fries, for \$4.59, from a kiosk! I'm not sure which surprised me more, the kiosks, which I had seen before, or the price of fries! Never had I not seen an option to pay with cash.

I see a great number of problems with this new cashless system taking hold, and one of the first just became apparent on the first of this month when minimum wage for fast food workers increased to \$20 per hour. That McDonalds I was in could probably run that store on 3-4 workers per shift non-peak hours, thereby eliminating almost that many jobs. Fewer entry level, non-skilled jobs available for entry level workers. That can't be good for our economy. Within the week, many chains have started to close locations that were already struggling with inflated wholesale supply costs. Franchisees of many chains are essentially mom & pop businesses, many of them will be squeezed out of business under this new minimum wage. Our Governor and the media seem genuinely shocked that this has already started to happen. And where then will entry level workers learn the skills necessary to be a good employee?

Now think about this, every time you make a purchase with your credit card, you're leaving a digital fingerprint. This administration has been after our banking information since day one of signing all those executive orders. The major banks staved off the order for a year, but now will have to report any transactions you make above \$600 instead of above \$2,000. Either is an invasion of privacy, but what if the government decides to base one's health care costs on how many French fries one buys at \$4.29? "Oh, that will never happen", I can hear it already. But then again, that's what we were told when we tried to warn people that boys and girls would be allowed to switch bathrooms at will.

On a side note, I did see an add this week for French fries for \$1.29, with the purchase of a \$10.00 quarter-pounder!!

Clearly, California can't go on with leadership creating these laws that have a domino effect through our economy. I do hope you will be with us for our

next meeting when our **Republican Party Chairman, Fred Whitaker** will be with us to talk about our way forward to the Fall election. I look forward to seeing you all at our next meeting on **April 26<sup>th</sup>**!

## City of Tustin History

### **Tustin Pioneer Charles Edward Utt**

Charles Edward “C.E. or Ed” Utt was born in Auburn, California, the only child of Lysander Utt and Arvilla Platt Utt, on March 23, 1866. His father had been one of the gold rush 49’ers, making and later losing his savings. He became a wood cutter, freight hauler and later a rancher. At the urging of his brother-in-law, Charlie Platt, he loaded up the family belongings on his wagon and headed to Tustin City, arriving in June 1874.

Lysander Utt purchased the empty Dickerson Store, at the corner on current Main and El Camino Real and started the L. Utt Pioneer Store. The family lived above the store and Arvilla Utt ran a boarding house in the upstairs. Young Ed helped tend the store, attended school and rented farm space anywhere he could find it. He liked farming more than tending the store.

After Lysander died in 1890, Ed ran the store with his new partner, Perry Lewis, until 1893, when he sold it to A. Getty. For many years, it was known as the Utt-Getty Store.

In 1894, he married Mary Sheldon, the daughter of Tustin’s first doctor, Dr. James Sheldon. The couple had five children, Gertrude (born 1894), Dorothy (born 1897), James (born 1898), Mary Louise (born 1900), and Elizabeth (1907). Mary Utt passed away suddenly in 1918. In 1920, he married Mrs. Margaret Cummings Rawlings.



Ed loved farming and grew walnuts, avocados, apricots, chili peppers, citrus and was one of the few successful peanut growers around. With over 400 acres of peanuts growing on the San Joaquin Ranch, he quickly became known as the “Peanut King”. Another very successful venture was the growing of Concord and Isabella grapes on his Lemon Heights land. They cooked Utt’s Grape Juice in his own kitchen until a commercial building could produce the juice. Utt had purchased the Victorian-

Italianate building at Main and Prospect in 1907 and in 1918, it became the Utt Juice Company.

With his partners James Irvine and Sherman Stevens, the trio purchased large amounts of acreage and started the San Joaquin Fruit Company. In 1897, Ed Utt purchased the Willard Brothers Water Works, turning it into the Tustin Water Works, expanding it, and running it for over 50 years. The City of Tustin acquired the Tustin Water Works in 1977.

Charles Edward Utt was active in the Tustin School District when it replaced the Sycamore School District in the 1890's, served on its board of directors, was active in the Tustin Presbyterian Church, and the Masonic Lodge. He died on February 5, 1950, at age 83.



**Marvin Eugene Gray**

Staff Sergeant,  
United States Army Air Corps  
70<sup>th</sup> Bombardment Squadron, 13<sup>th</sup> Air Force  
Born 3 March 1922  
Killed in Action 9 March 1945  
Philippine Islands

Marvin Eugene Gray was born in Kansas in 1922, the oldest child of Charles C. and Beulah Margaret Gray. The family moved to Tustin after 1935 and Marvin graduated from Tustin Union High School in 1940.

He married Doris Gehres in Yuma, Arizona on February 8, 1942 and enlisted in the service on May 17, 1943. He completed his training at Fresno, Colorado and South Carolina before departing for duty in the South Pacific in June 1944.

With the 13<sup>th</sup> Air Force, he completed 43 missions as an armored gunner and participated in air action over the Himalayas, Borneo, Celebes, Luzon and the Philippines. On March 9, 1945, Sgt. Gray was killed in action in a mid-air collision over the Philippine Islands. He had just turned 23 years old, 6 days prior to his death. He left behind his wife Doris and a two year old daughter, Diana.

He was awarded the Air Medal with one Oak Leaf Cluster and the Purple Heart. He is buried in Fairhaven Cemetery in Santa Ana.

Gray Place in Tustin Ranch is named in his honor.
