## **President's Report**


Dear TARWF Members,

## **City of Tustin History**



**Donna Peery**, Office Manager of the **Tustin Historical Society** has agreed to contribute articles for our newsletter regarding Tustin history and Tustin armed forces service personnel.



**Byron Asa Crawford** 

Byron "Barney" Crawford was born on 10 April 1878 to William Foster Crawford and Ella Jewel in Ripon, Fond du Lac County, Wisconsin. He came to Orange County in 1888 with his family and attended Tustin Grammar School, Santa Ana High School and Los Angeles Business College.

He operated a stage line that went from Needles to Searchlight, Nevada from 1904-1906 and made his home in Searchlight. After marrying Violet Forney on 22 February 1906 in Los Angeles, Barney and Violet moved to the Pomona area, where Barney began working in the citrus packing houses.

In 1913, the couple moved to Tustin and Barney went to work for the San Joaquin Fruit Company on the Irvine Ranch. In the early 1920's he was the manager the Tustin Hills Citrus Association, a position he held until his death.

By the mid 1920's the couple, with their young children Dudley, William, Janet and Kenneth moved into 445 W. Second Street (the Vandermuellen-Bennet House) in Tustin.

When Tustin decided to incorporate, it went to a vote of the 900 Tustin citizens on September 14, 1927. The count was 248 in favor of incorporation and 110 against. Nine citizens were on the ballot for what was called the Board of Trustees. Byron Crawford received the most votes, with 136 votes and became President of the Board of Trustees. In their second board meeting, the Trustees renamed themselves and became Tustin's first City Council and Byron Crawford, the first Mayor of Tustin. He served from

1927-1932.

Barney was active in the Knights of Pythias, the Santa Ana Elks Lodge, Masons, Rotary Club and the Farm Bureau. He loved horses, horse shows, western movies and sports. He passed away in 1947 and is buried at Melrose Memorial Park in Anaheim.



**Derril Charles Wollert** Ensign United States Navy Born 26 January 1921 Missing in Action 19 September 1943

Derril Charles Wollert was born on 26 January 1921 in Hennepin, Minnesota, the middle child of five to Henry C. Wollert and Alice Carlson Wollert. The family moved to Orange County in 1925 where Mr. Wollert was the manager of T-O Paint Company before starting his own successful business. Until his passing in 1971, Mr. Wollert was the owner of Wollert Interiors and HC Wollert Paint Company. From 1944-1946, Mr. Wollert ran his business from the Martin Home, which is now Jeff and Cherie Thompson's Historic home on 6th Street in Tustin.

Derril attended Orange High School and was quite active in school and in leadership. He was a member of the Drama Club and had a leading role in the play "You and I" during his senior year. After Orange High, he attended Santa Ana College and by graduation had two years of flying to his credit. Shortly after his 21<sup>st</sup> birthday, Derril enlisted in the United States Navy Air Corps. He left for training on March 26, 1942 and received his training in Long Beach, followed by aviator training in Corpus Cristi, earning his wings in October 1942.

Ensign Wollert was sent overseas in August 1943 to the South Pacific as a torpedo pilot with Squadron V-T 1. Less than one month later, Ensign Wollert was killed when his plane crashed, his remains were never recovered.

He is listed on the Tablet of the Missing at the Honolulu Memorial Cemetery.

# Biden's claims vs. reality (And this is just some — we lost count!)

CLAIM "Some Republicans want Medicare and Social Security to sunset."

ARE PAR The biggest lie of the night. No one has proposed this. Republicans want the promise of less spending tied to the debt ceiling, they have not said Medicare or Social Security will sunset.

"We have created a record 12 million new jobs, more jobs created in two years than any president has ever created in four years."

TRUTH No jobs were "created." After the vaccine was developed and COVID lockdowns lifted, businesses sprang back and rehired many who were laid off. Biden had nothing to do with it.

N MALINI "Inflation has been a global problem because of the pandemic that disrupted supply chains and Putin's war that disrupted energy and food supplies."

Yes, but it was particularly bad here because of the massive spending by the government.

"The Inflation Reduction Act is also the most significant investment ever to tackle the climate crisis . . . Lowering utility bills."

**NRUME** Con Edison in New York alone says gas bills will be up 20% this year. Renewables have not been able to keep up with demand, and regulations have only driven up the cost of fossil fuels.

"They invested too little of that profit to increase domestic production and keep gas prices down."

It takes a lot of chutzpah for Biden to claim oil companies haven't drilled enough! He canceled pipelines, would not sign new drilling licenses and made no secret of the fact that he wanted to drive oil companies out of business. And they didn't drill enough?

"We pay more for prescription drugs than any major nation on Earth."

TRUPH We also have the most innovation of any nation, with access to the latest treatments first.

"Under my plan, nobody earning less than \$400,000 a year will pay an additional penny in taxes. Not one penny."

With the increase in the number of IRS agents they certainly will. And new "minimum" rates for corporations will be passed along to all of us. Not to mention inflation as a tax.

"Because no billionaire should pay a lower tax rate than a school teacher or a firefighter."

TRUCK The White House claimed in a fact sheet that "In a typical year, billionaires pay an aver-age tax rate of just 8%." To get to that number, the White House includes unsold stock owned by the 400 wealthiest families as "income." They would pay taxes on it if they sold it! Independent tax analysis show that the wealthiest pay 22%-25% a year in income taxes -- not lower than a schoolteacher or firefighter, who pay much less. The rich paid a whopping 42.3% of all federal income taxes last year.

"In the last two years, my administration cut the deficit by more than \$1.7 trillion - the largest deficit reduction in American history."

TRUTH That's only because the deficit dropped when temporary COVID stimulus spending lapsed. The national debt was roughly \$27.75 trillion when Biden took office, according to the Congressional Research Service, now it's \$31.43 trillion. He grew the deficit by more than \$3.6 trillion but less than was originally projected.

ALM I "In the midst of the COVID crisis when schools were closed, let's also recognize how far we've come."

They were closed for far too long because teacher's unions were allowed to dictate government policy. And Biden's response to the education crisis? Not more charter schools, not a focus on the fundamentals, but more money.

"Public safety depends on public trust. But too often that trust is violated.... imagine what it's like to lose a child at the hands of the law."

While Tyre Nichols is a tragedy, the number of people killed by law enforcement in any year is very small - and almost all of them are armed and in the process of committing a crime. Far more young black men die from gang shootings, something Biden did not mention.

"Since we launched our new border plan last month, unlawful migration from Cuba, Haiti, Nicaragua, and Venezuela has come down 97%."

TRUTH That number is questionable because it just looked at one week after the new year, but crossings overall are still at record highs.

"Today, we're in the strongest position in decades to compete with China or anyone else in the world."

Except when a balloon sails over the whole United States.
