NEW ORANGE COUNTY VOTING SYSTEM

There will be NO precinct voting and ALL registered OC voters will be mailed a vote-by-mail ballot. There will also be 188 “Vote Centers” located throughout the County where in-person voting and other voter-related business can be conducted. These are in accordance with the 2016 “Voter’s Choice Act” (SB450).

Vote-by-mail ballots will be sent out the week of February 3, 2020. **REMEMBER ELECTION DAY IS TUESDAY MARCH 3, 2020!** If you want to vote for President Donald Trump in the Primary (March 3, 2020) you must be registered as a REPUBLICAN! Give all your friends this information!

The following is information received from a presentation by Neal Kelley, OC Registrar of Voters, at the Republican Central Committee Meeting in October, 2019.

1. You can vote-by-mail 29 days out.
2. Starting February 22 through March 3, 2020, including Saturday and Sunday, 8 – 5 pm, you will be able to vote at one of 38 OC Vote Centers. You will be greeted and checked in electronically. Casting a ballot should be quick and easy or you can drop off your completed vote-by-mail ballot at the Vote Center location. (Locations of Vote Centers should be forthcoming.)

3. Starting February 28 through March 3, 2020, including Saturday and Sunday, 8 – 8 pm, you will be able to vote at one of 188 OC Vote Centers. You can also drop off your completed vote-by-mail ballot at a Vote Center location. (Locations of Vote Centers should be forthcoming.)

4. There will also be 110 secure ballot drop box locations throughout Orange County. Voters will be able to deposit their ballot into a secure drop box between February 3 and March 3, 2020. (Locations should be forthcoming.)

Orange County is under this new voting system, but not all counties in California are under this new system yet.
