Reminder, TARWF does not have General Meetings during the summer months of June, July and August.


We will continue to have monthly TARWF Happy Hours the second Tuesday of

City of Tustin History

of the **Tustin Historical Society** has agreed to contribute articles for our newsletter regarding Tustin history and Tustin armed forces service personnel.



If you have ever been to the Marshall's/Home Goods store on 1th Street at Carroll Way, you are at the former ranch owned by early Tustin Pioneer John Dunstan.

John Dunstan was born on December 5, 1866, near Cornwall, England, the only child of James Dunstan and Elizabeth Berryman. When James Dunstan arrived in New York City in 1867, he immediately headed west, first to Iowa, then to Nevada and arrived in Tustin in 1875. James purchased 20 acres and

planted grapes, oranges, and apricots.

John began buying acreage, first off Bryan Avenue and planted walnuts and apricots, and later oranges and lemons. In 1903, he sold this acreage and purchased 30 acres on East Seventeenth Street and built a lovely craftsman style home in what is now Tustin's French Quarter Shopping Center. The home was demolished to build the Marshall's Store and surrounding shops. Sixteen of his acres were devoted to growing Valencia Oranges and John managed those acres as well as his mother's adjoining orchard. John marketed his oranges to the Santiago Orange Growers Association and was a long-time member of the association. He was on the board of Directors of the Santa Ana Valley Irrigation Company and served as its President.

On 16 April 1902, he married Myrtle Hall and the couple had three children: Gilbert Hall Dunstan, Mary Elizabeth (later Mrs. George Broomell) and Frances Emily. The children attended Santa Ana High School and Frances Tustin Grammar School. Gilbert attended USC and received his Master's degree from the University of Iowa. He taught electrical and sanitation engineering at USC, Tulane University and Washington State University. Mary attended USC where she received her general education degree and taught at Tustin High School. Frances also attended and graduated from USC and was a bookkeeper at the First National Bank of Tustin.

When the First National Bank of Tustin opened its doors on February 5, 1912, John Dunstan became the Vice President. He resigned his position at the Santa Ana Valley Irrigation to devote his time to banking, farming his oranges, and assisting his mother.

John Dunstan passed way in 1944 at age 77 and is buried at Santa Ana Cemetery. Dunstan Drive in Tustin Ranch is named for John Dunstan.



Christy Albert Peebler Sergeant United States Army 196th Light Infantry Brigade Born 24 January 1947 Killed in Action 13 June 1969 Vietnam

Christy (Chris) Albert Peebler, the middle child of Gerald Peebler

and Harriette Payne Peebler. Chris was born in Orange, CA on January 24, 1947. His father Gerald was a US Army Veteran, having served in World War II. He had an older brother John Scott and younger sister Janice.

He had been an independent paper carrier for a daily newspaper and was in Little League. In his scouting activities, he achieved Star rank. While in high school, he was a member of the Agriculture Explorers. He worked with his family at their laundry and dry cleaning business in Santa Ana.

Sgt. Peebler attended Edison and Roosevelt Elementary Schools and Lathrop Jr. High in Santa Ana before coming to Tustin. He was graduated from Tustin High in 1965, then attended Santa Ana College for 2 1/2 years, receiving his Associate of Arts degree in Diesel and Automotive Engineering. During July and August of 1966, he attended a summer session at the University of Wales in Bangor, Wales.

He enlisted in the United Sates Army in February 1968, completing his basic training at Fort Lewis, Washington. He was sent to Vietnam on August 15, 1968.

At the time of his death, Chris was engaged to be married on August 2nd to Lynda Douthit of Tustin. Six days before his death, his mother and father were to take his fiancé to meet Chris in Hawaii when his mother saw uniformed soldiers walking up her driveway. Sgt. Chris Peebler had been shot through the heart by a sniper's bullet while on patrol near Chu Lai, Vietnam.

He was the recipient of two Purple Hearts (he had incurred serious wounds that he had recovered from earlier), the Presidential Unit Citation, the Vietnam Service Medal, the Vietnam Campaign Medal and the Bronze Star.

He is buried at Olive Lawn Memorial Park in La Mirada.

SPECIAL REPORT – The Trump Indictment

Late last night, news broke that was not entirely surprising, but it is completely disgusting. Donald Trump is now the first former president to be indicted on federal charges. Here are four observations about the indictment.

ONE. Make no mistake about it: This is yet another example of federal law enforcement agencies meant to protect us from criminals and foreign enemies being turned against us and employed as a weapon against half of America and Donald Trump.

The purpose of this indictment is to turn the one candidate that the left fears most into a criminal to ensure that the left keeps power. This is the stuff of Third World dictatorships.

TWO. The natural reaction to this news is to respond based on whether you like or dislike Donald Trump. That is a mistake. Our reaction should be based on whether we believe in the rule of law or whether we are willing to surrender our constitutional Republic to fascist left-wing extremists.

Depending on how you count it, this will be the sixth time that the Deep State has interfered in an election.

THREE. The depth of the corruption in our federal institutions and their politicization is breathtaking. No reasonable person can believe it is merely a coincidence that just as the <u>FBI is forced to reveal a document</u> that finally puts the corruption charges against Biden on the front pages, Trump is suddenly indicted with predictable results. Biden's corruption is off the front page, and the charges against Trump are everywhere.

FOUR. This action reveals the Biden campaign strategy in 2024. He will hide in the White House basement while government agencies established to protect us are used to go after Donald Trump and conservative leaders.

Some additional points to consider.

Charlie Kirk, former Representative Lee Zeldin and many others today, including me, believe that every Republican competing for the 2024 presidential nomination should go to Mar-a-Lago and make a joint statement of solidarity, even though they will continue to compete with Trump for the nomination.

Some may privately think this is a great development because it damages Trump and improves their chances of becoming president. That would be a terrible mistake. This damages America.

What is happening right now is a real insurrection. If the Deep State continues to get away with this tactic, any conservative who manages to prevail in 2024 will be subjected to the same treatment, unless they are willing to be a weak president who doesn't actually do anything to resist the left's neo-Marxist agenda and stop the slide into authoritarianism.

I am struck by how even some Trump critics are deeply troubled by this indictment and the continued trend of interference in our constitutional Republic's elections by the politicized Deep State. Some of them are pointing out that selective criminalization aimed at political opponents is in fact political repression that must be stopped or the country is lost.

Once again, it must be noted that this is not specific to Trump. This selective criminalization is also being done to <u>pro-life activists</u>, <u>other conservative officials</u>, <u>conservative churches</u>, not to mention the heavy-handed prosecutions of January 6th demonstrators compared to the violent 2020 rioters.

Every day a new story emerges of leftist ideologues in our elementary schools showing little children totally inappropriate material favored by the LGBTQ crowd. Yesterday, <u>Joe Biden</u> stood with those radical forces.

At the same time, multiple<u>groups representing parents</u> who are fighting back against this insanity are labeled by powerful left-wing interest groups as equivalent to the KKK.

This has absolutely nothing to do with Donald Trump, but today's left is comparing parents – you and me – to the most vicious, hated groups in America because we don't want our kids indoctrinated with radical ideas about sex and gender.

Let me also remind you about Special Counsel Jack Smith. He earned his place in the left's "Hall of Heroes" with his prosecution of former Virginia Governor Bob McDonnell in 2014. At the time, McDonnell was a rising star in the Republican Party. But Smith's prosecution destroyed McDonnell.

Later, when it no longer mattered, Smith's corruption case against McDonnell was thrown out by the Supreme Court in a <u>9-to-0 decision</u>. That tells you everything you need to know.

One final thought on the charges themselves.

Many people will say, "But Trump took classified documents." Officials with the <u>National Archives testified</u> before Congress in March. They admitted that every president from Ronald Reagan on has had disputes with the federal government over whether certain documents belonged to them or the federal government.

Some of those disputes have dragged on for years. Former <u>President</u> <u>Obama</u> took more than 30 million pages of documents to his presidential library.

The National Archives officials also admitted that at least 80 times since 2010, the Archives has received calls from libraries after finding classified documents among the papers turned over by former members of Congress.

The reason there are so many disputes is because we have a major overclassification problem in Washington, which the left has now weaponized. And, of course, when it comes to presidents, they can declassify anything they want.

So, from the dawn raid at Mar-a-Lago, involving dozens of agents with automatic weapons, to this indictment, Donald Trump is being treated differently than any previous president.

Why? Because he speaks for at least 75 million Americans who are angry about the direction America is going and has been going for the past 40 years. The neo-Marxist left wants to get him and it wants to get us.
